To this end, the Fund invests in listed shares of companies and institutions in member states of the European Union, Norway, the United Kingdom, and Switzerland. The value of the assets may fluctuate significantly as a result of the investment policy, both in absolute terms and relative to the Index. The Fund observes the UCITS investment restrictions and invests no more than 10% in undertakings for collective investment in transferable securities.

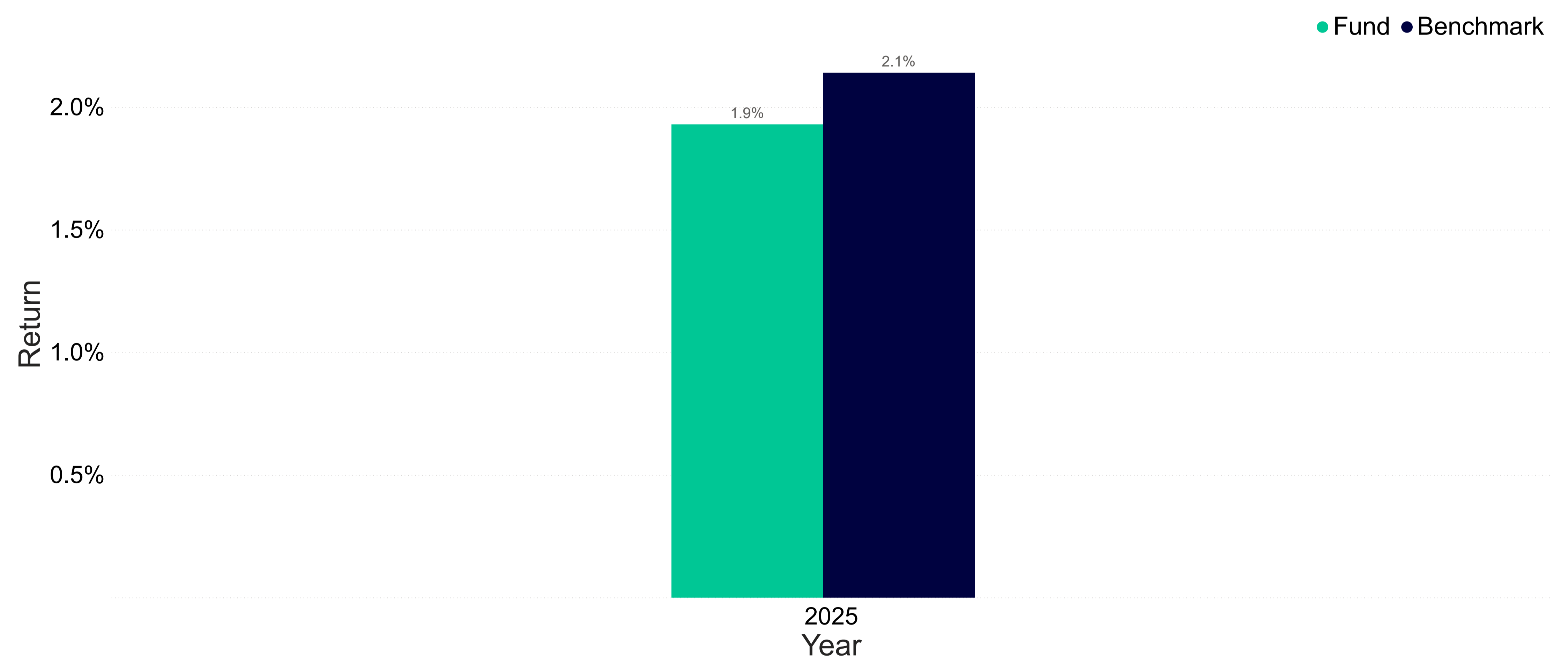

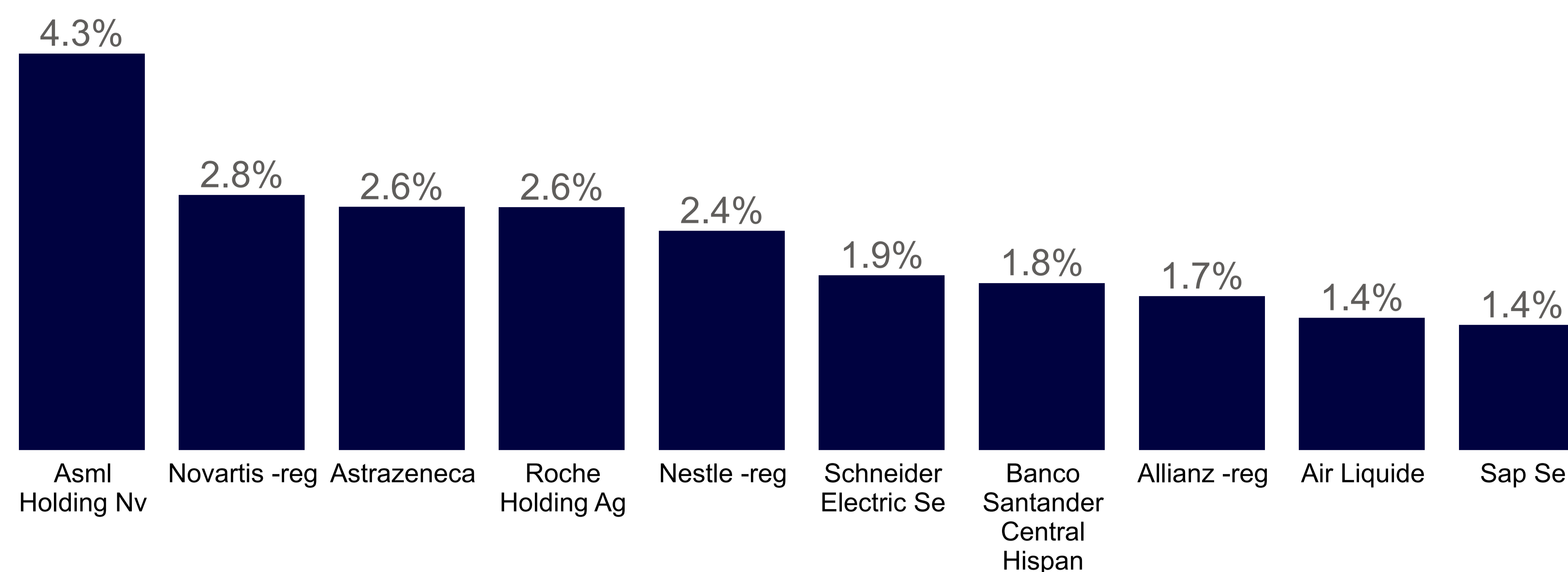

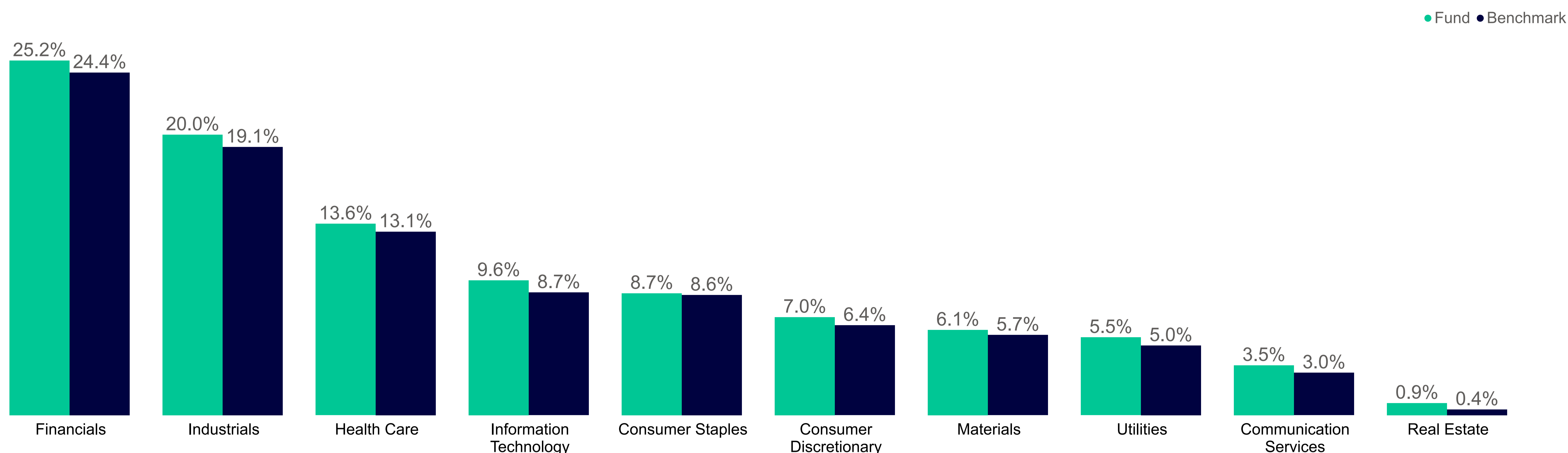

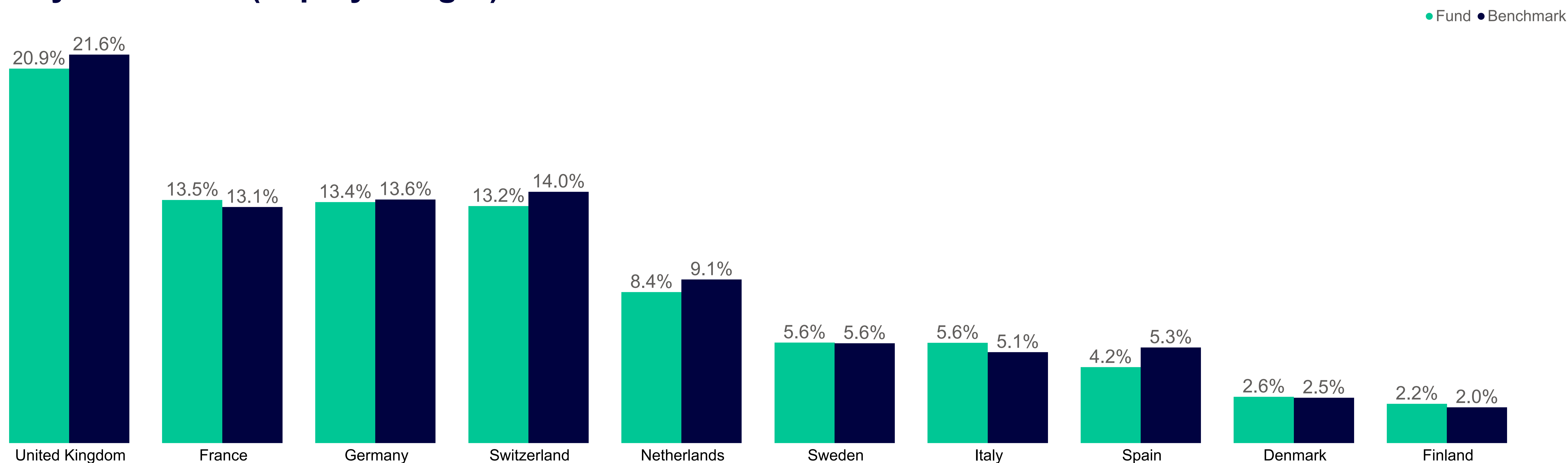
Top Holdings by Weight



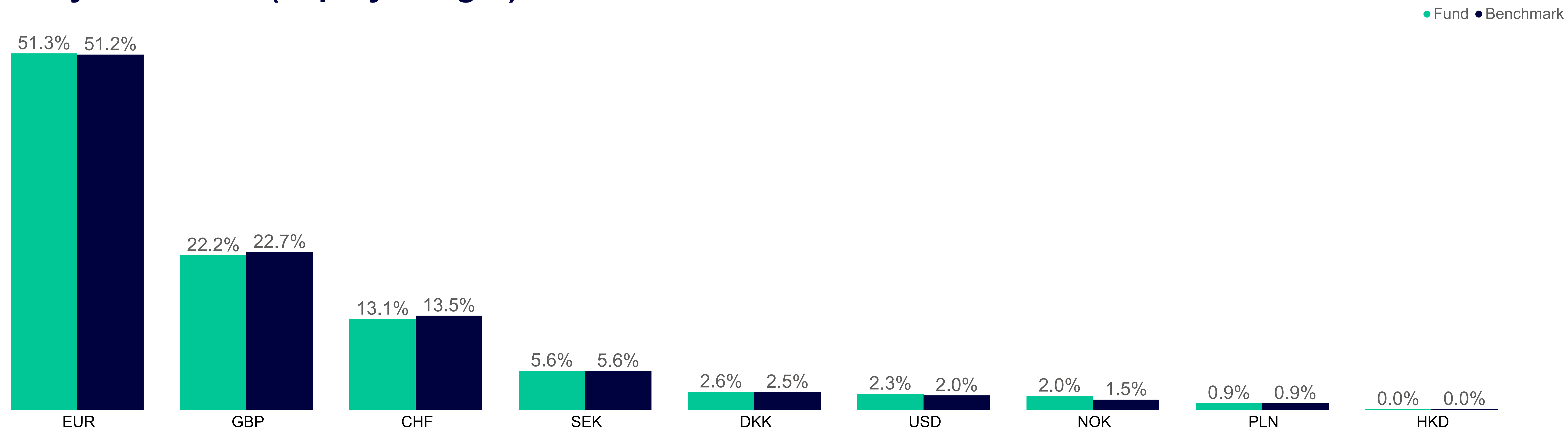
Sector Allocation (Top by Weight)



Country Allocation (Top by Weight)



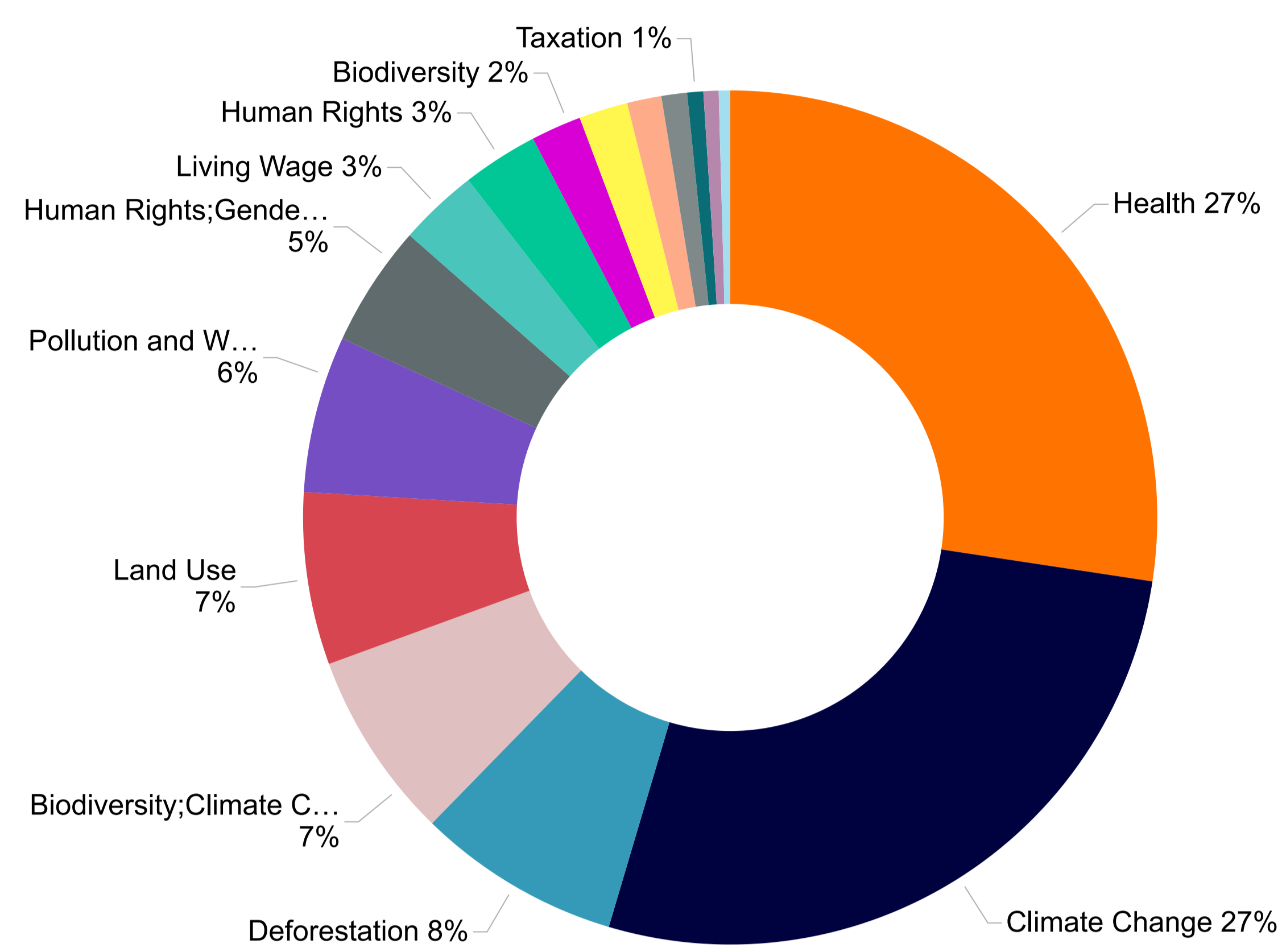
Currency Allocation (Top by Weight)



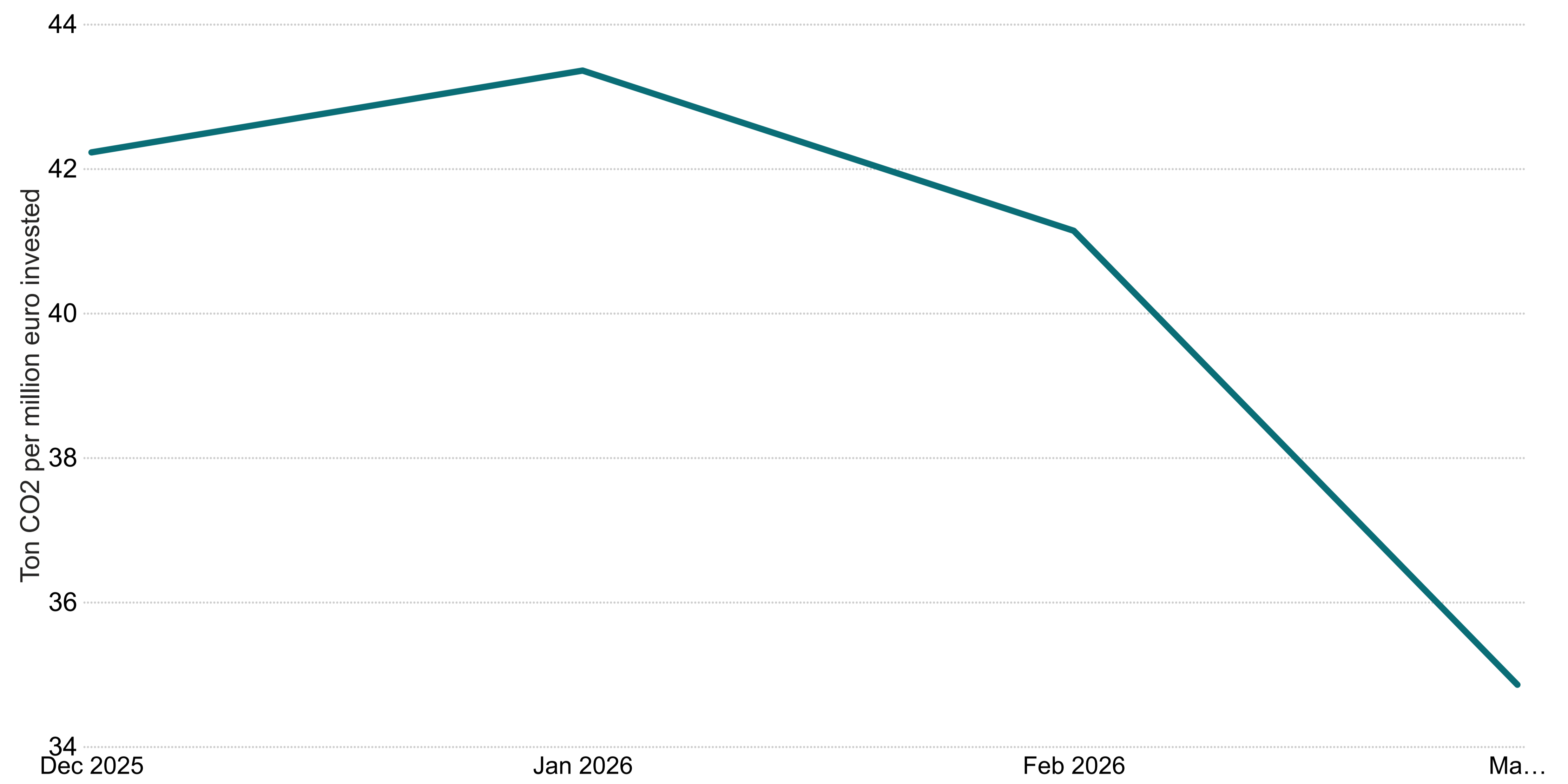
