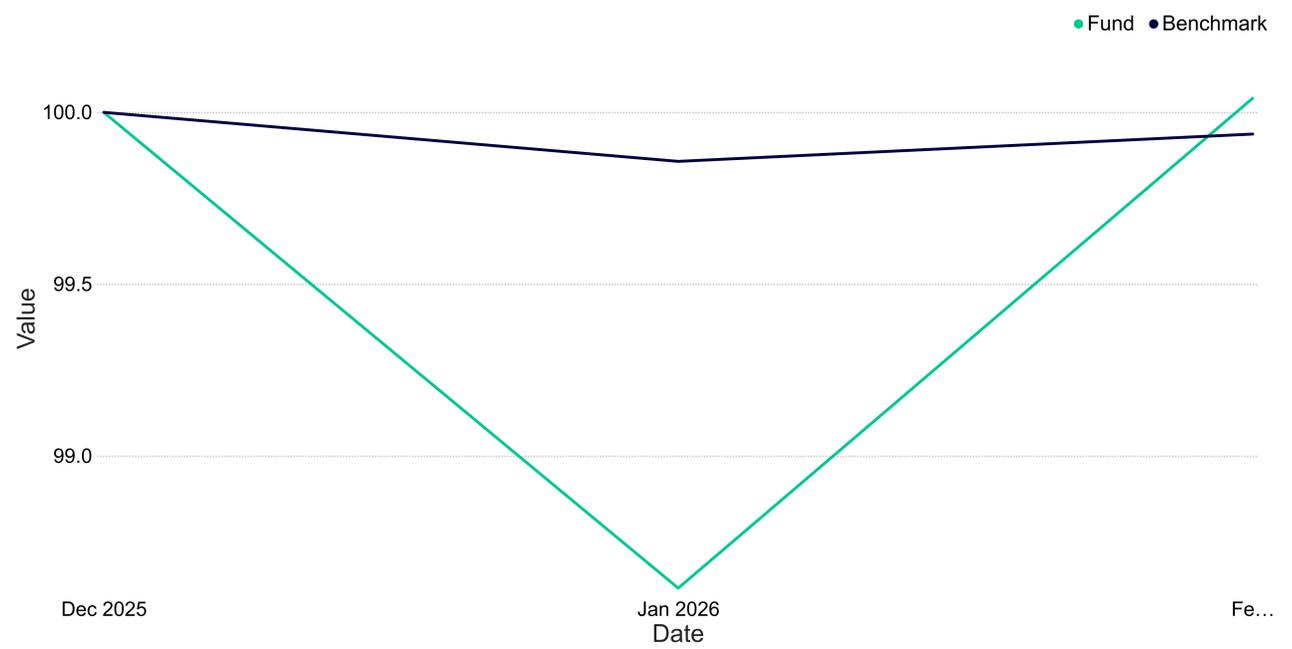

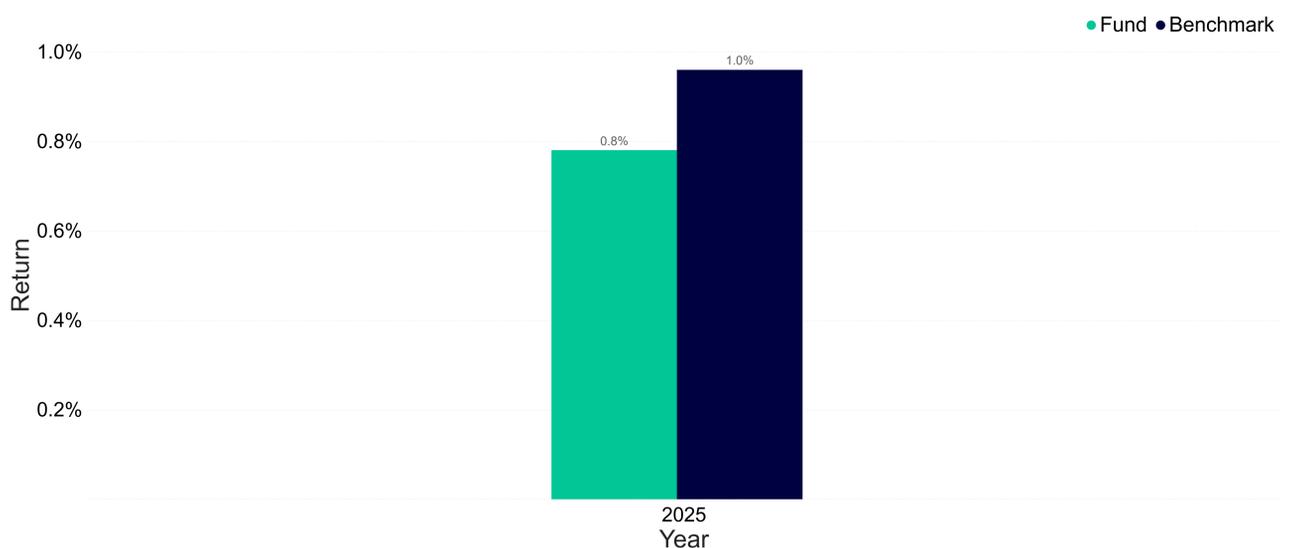

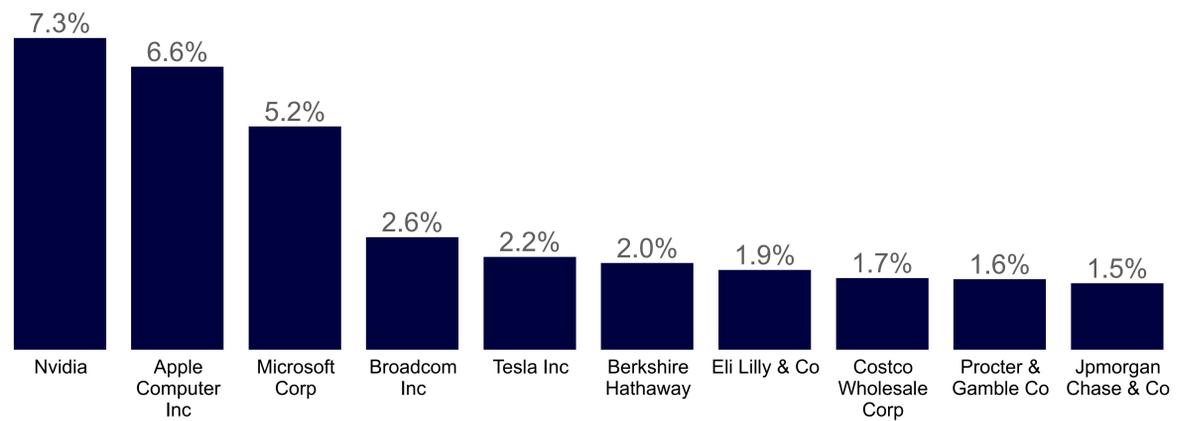

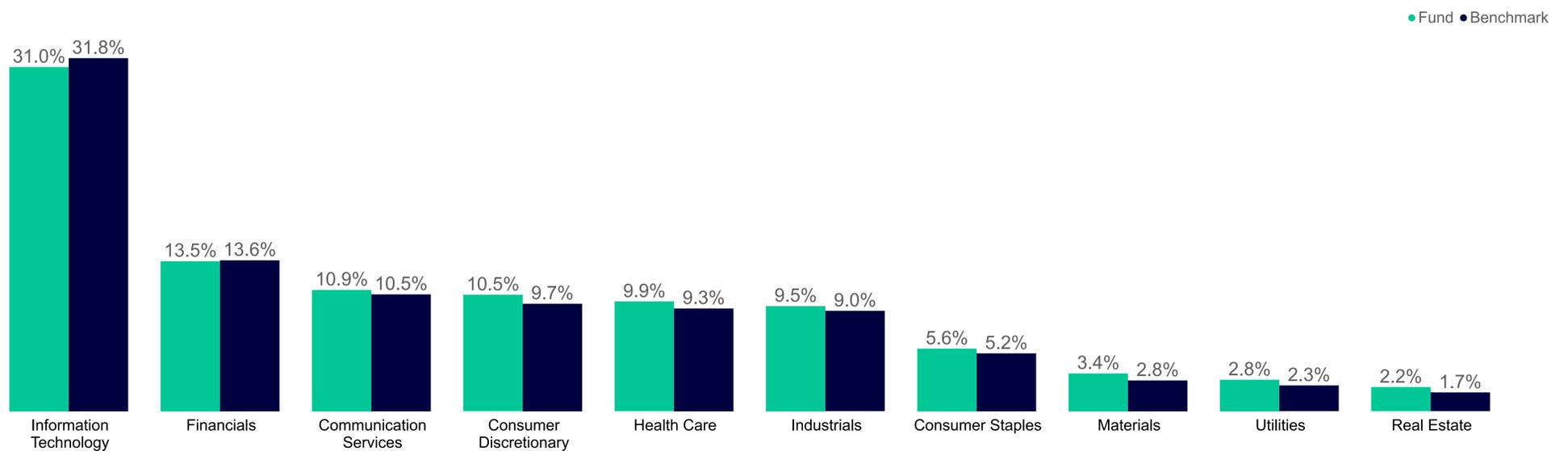

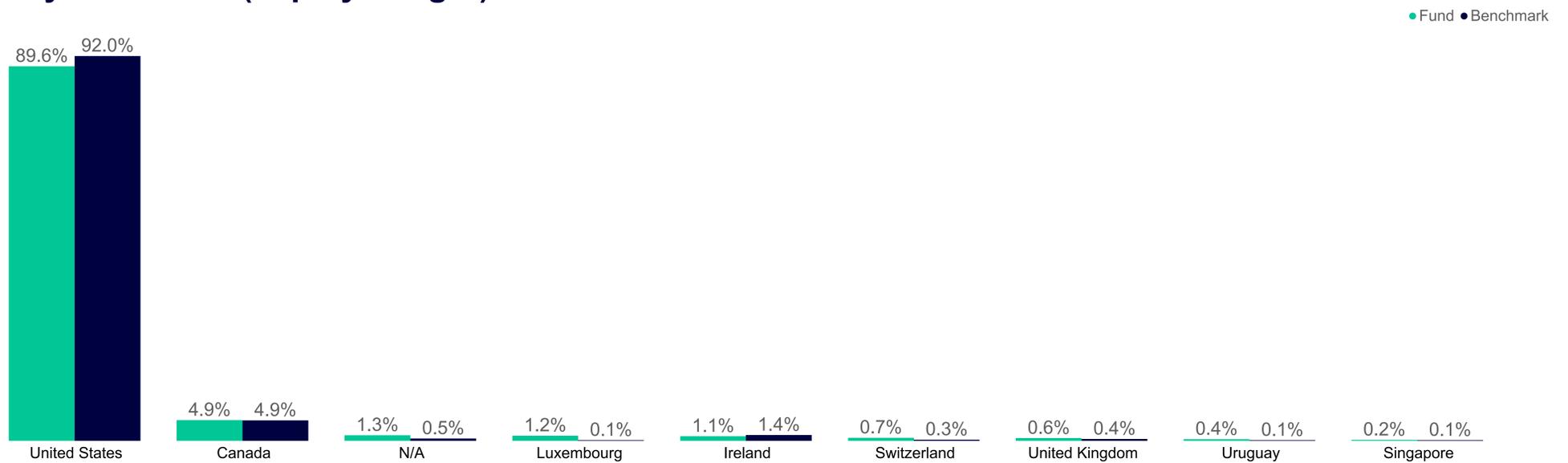
## Top Holdings by Weight



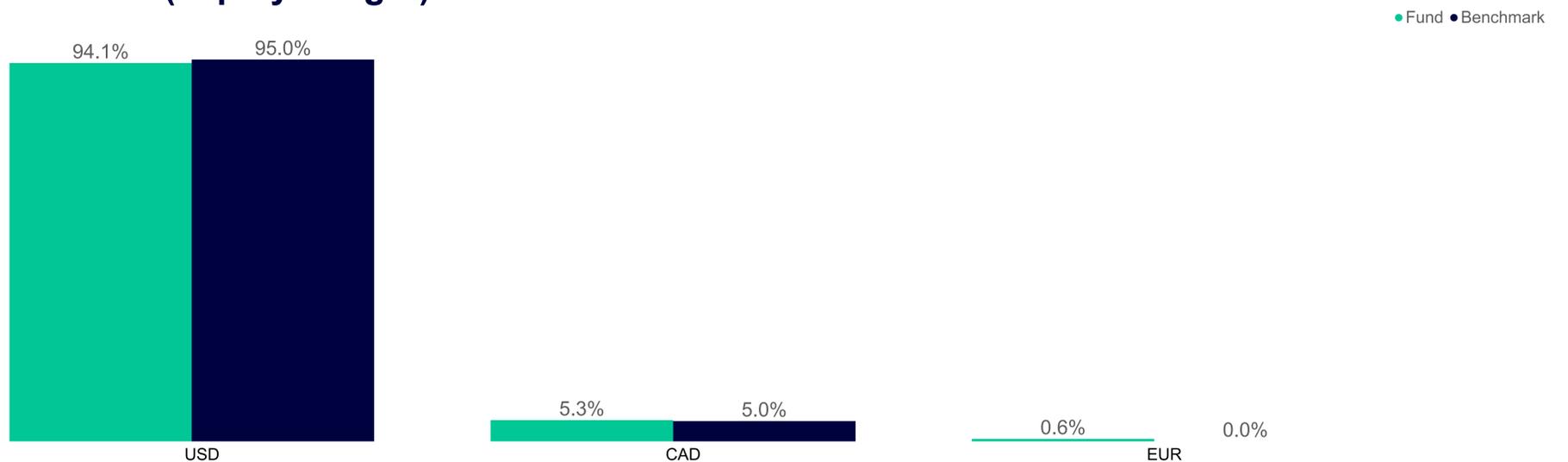
## Sector Allocation (Top by Weight)



## Country Allocation (Top by Weight)



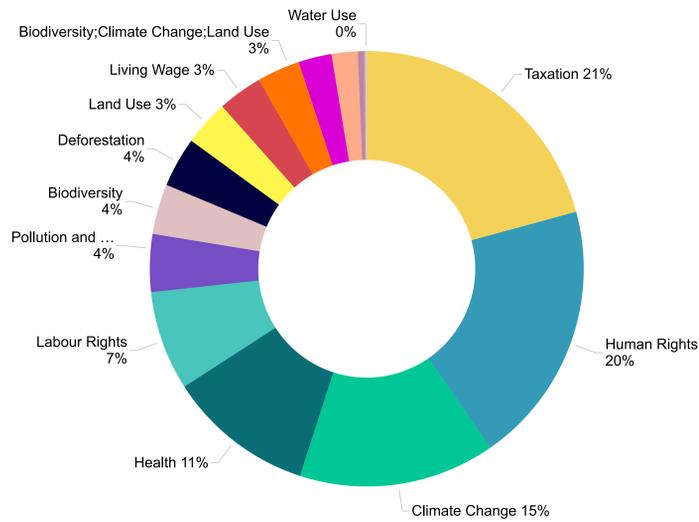

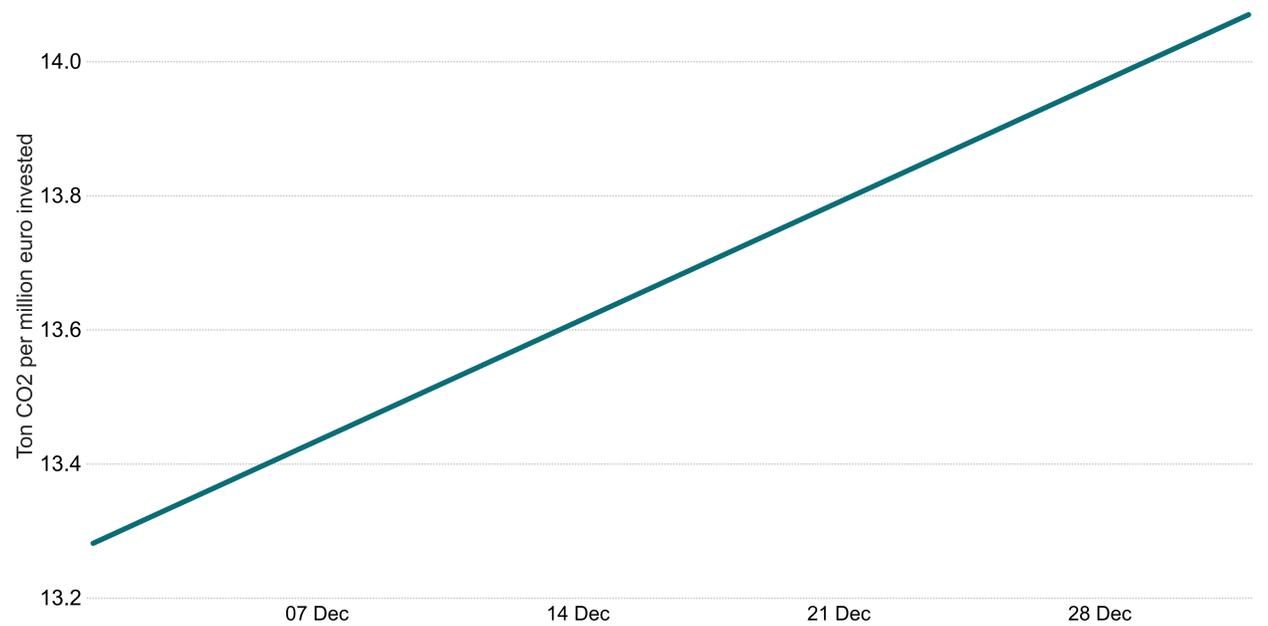
