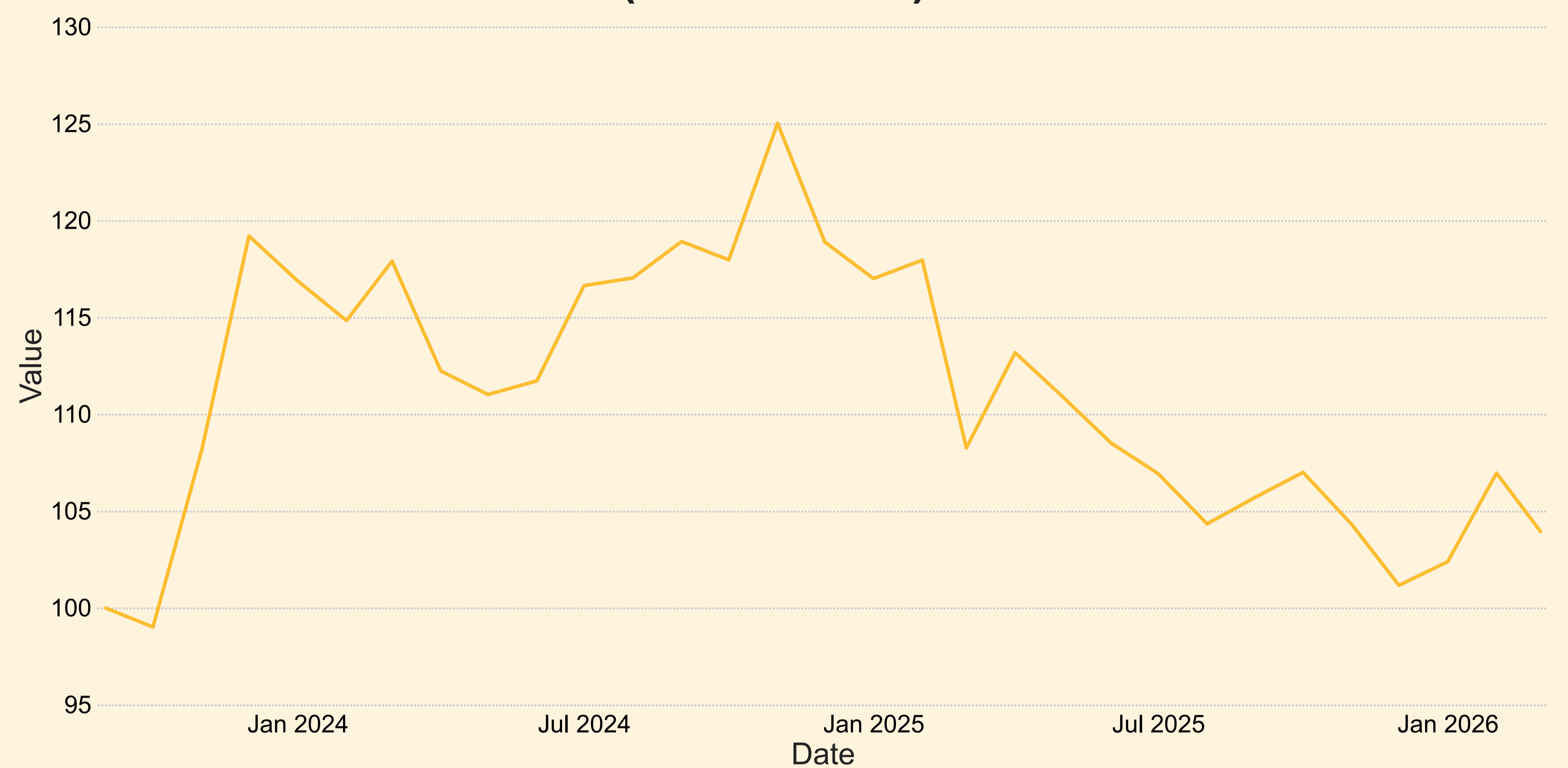

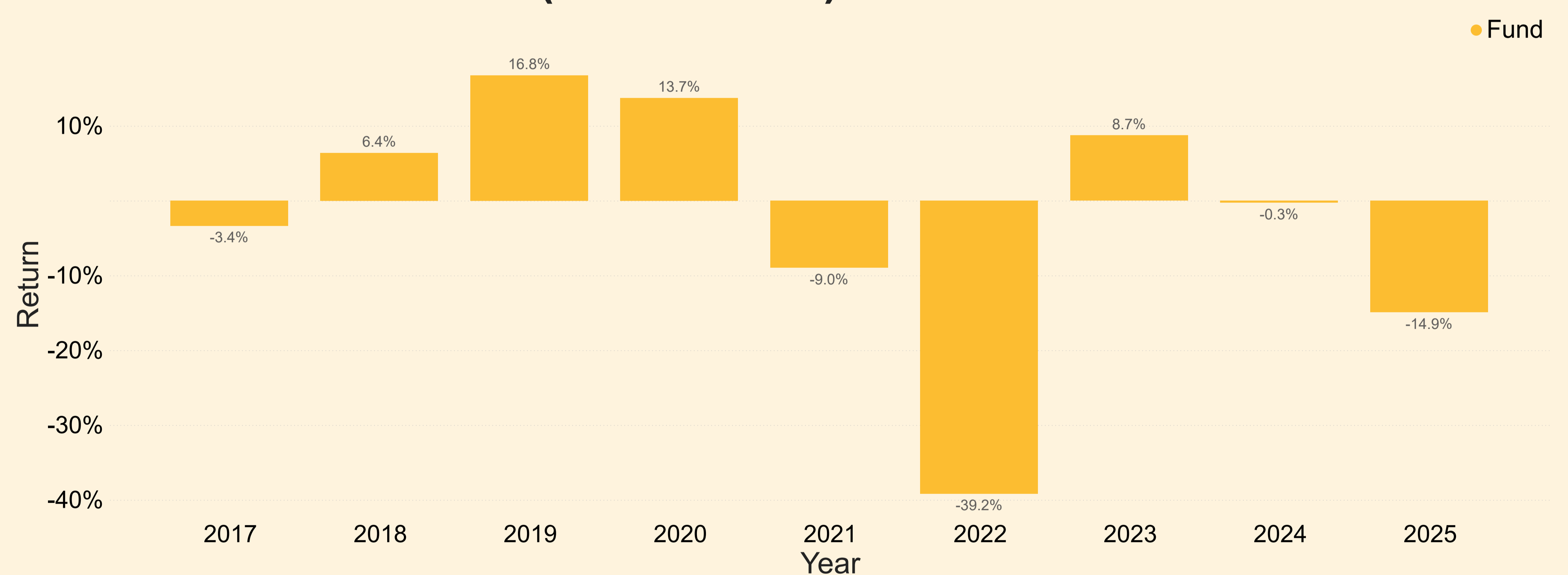

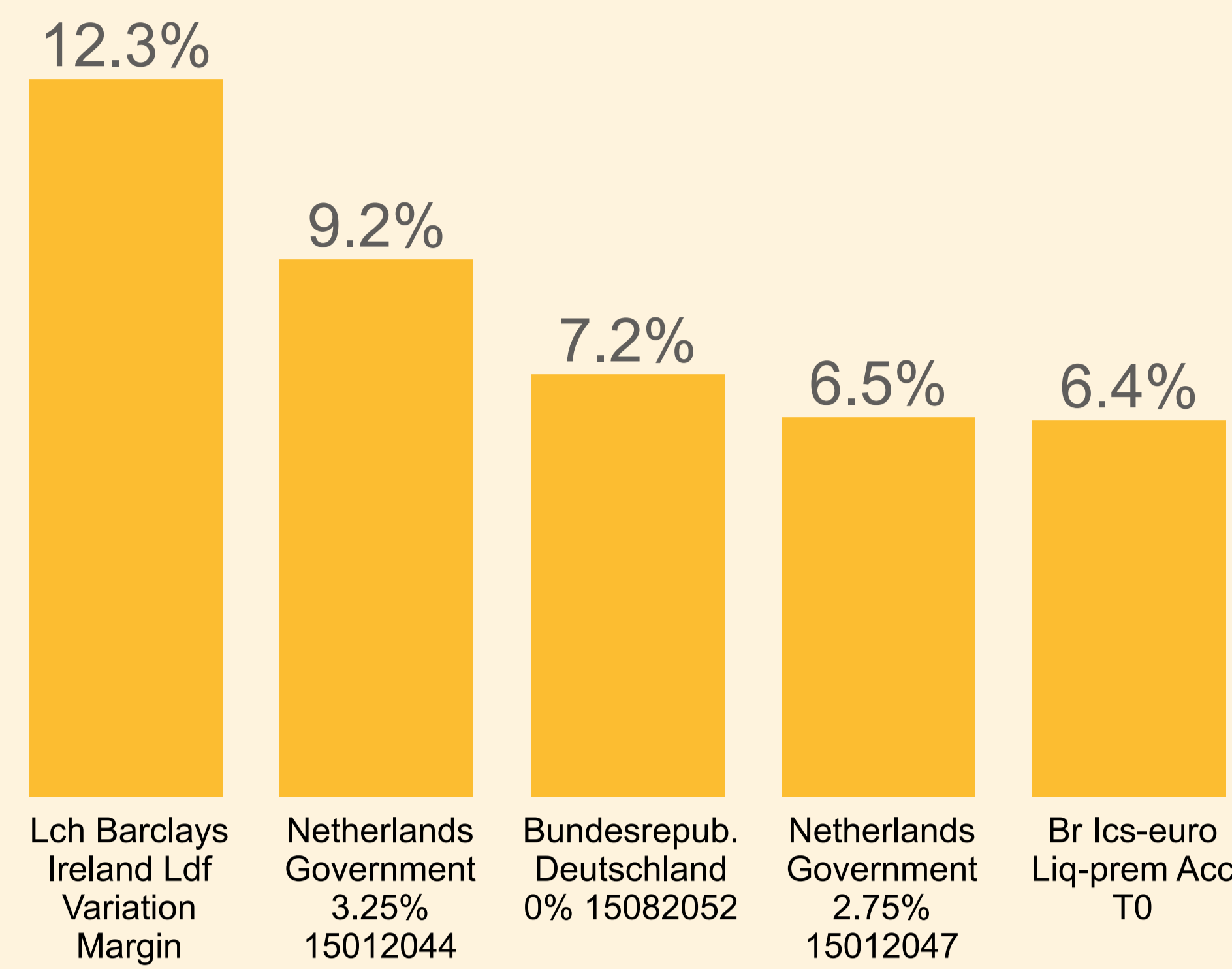

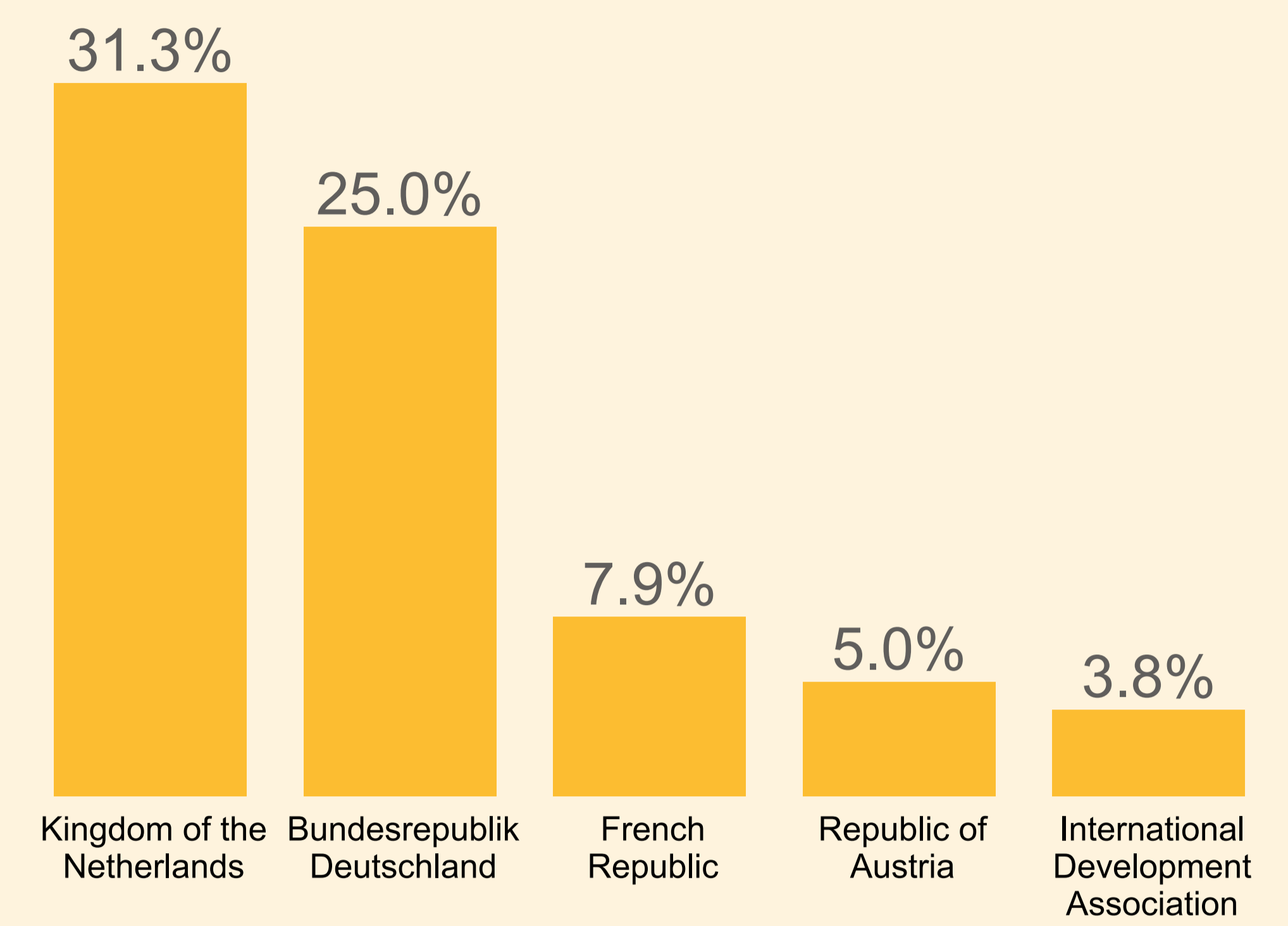

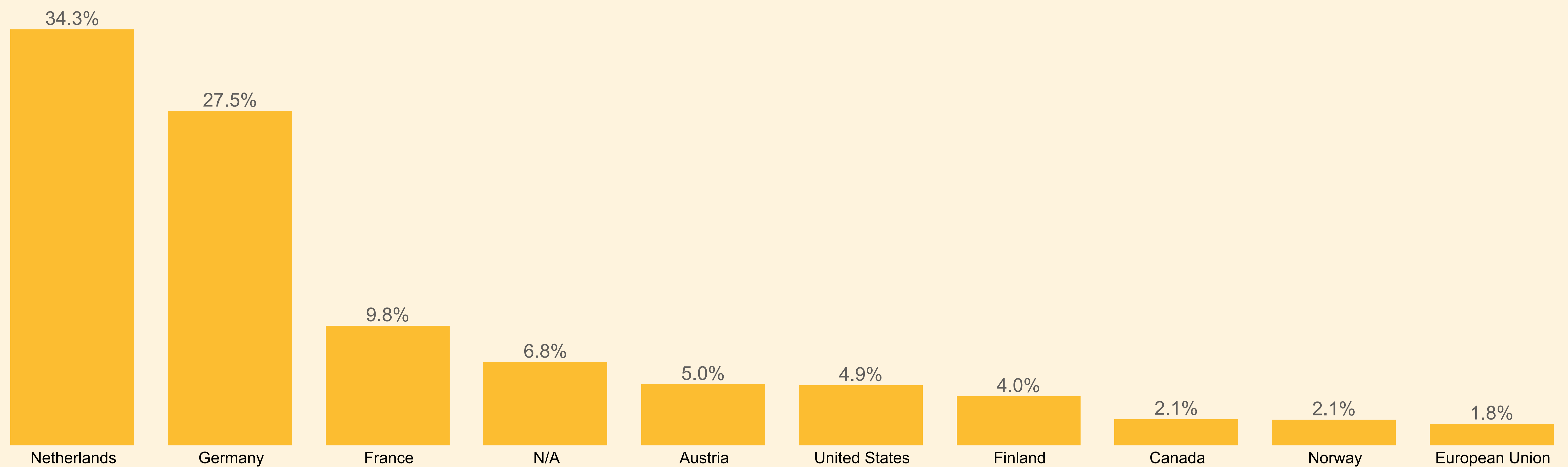
Top Holdings by Weight



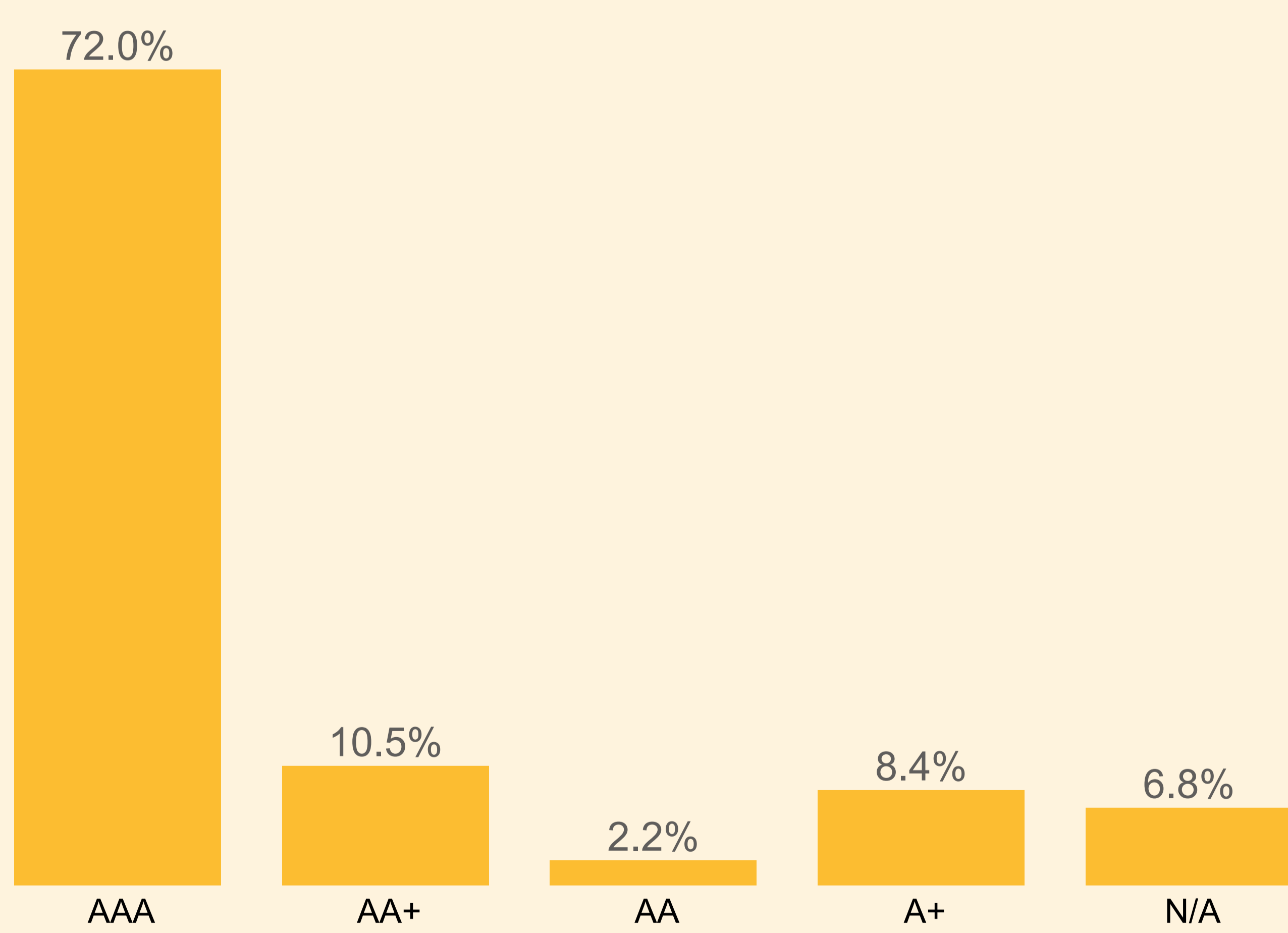

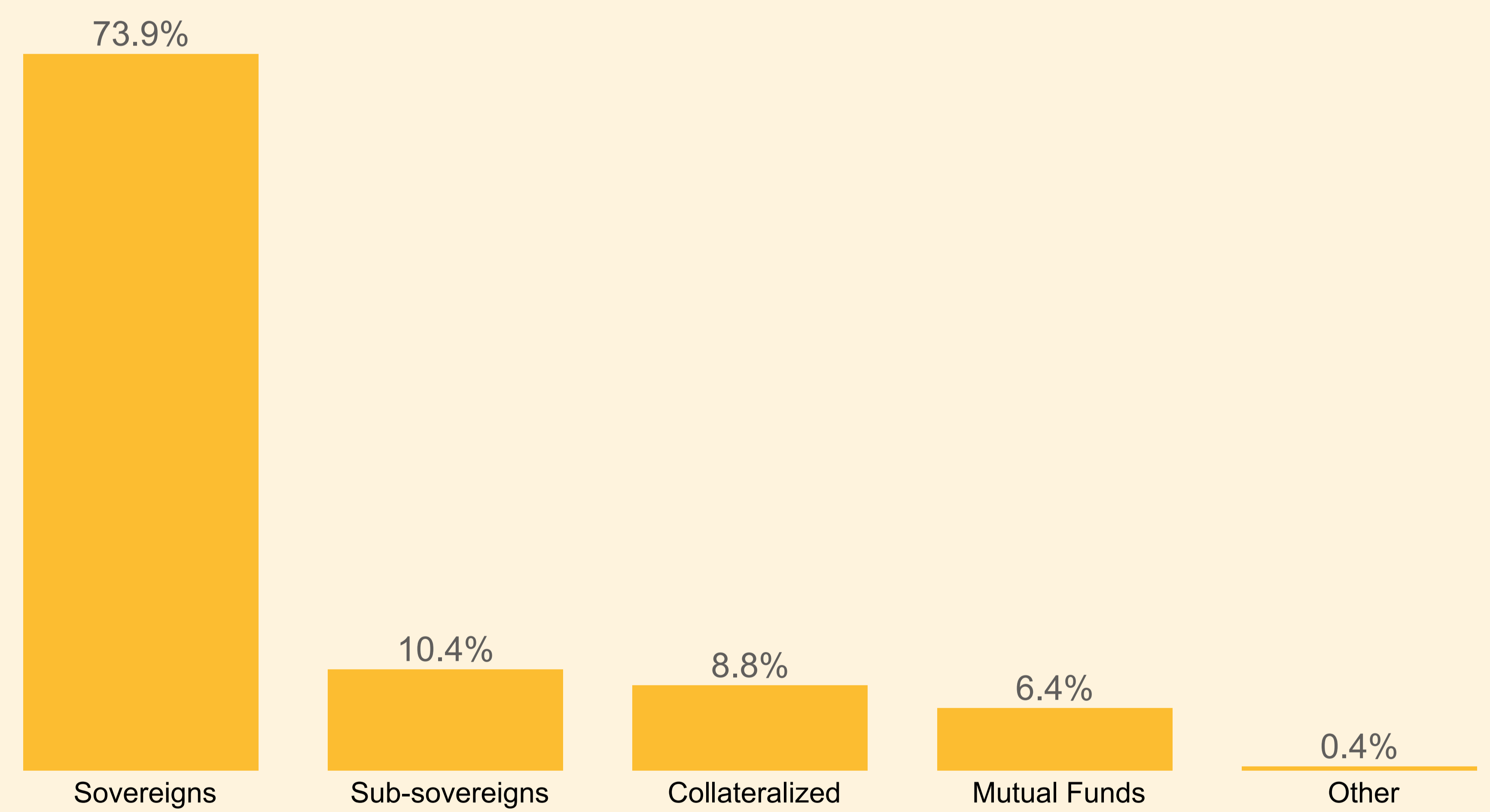
Country Allocation (Top by Weight)

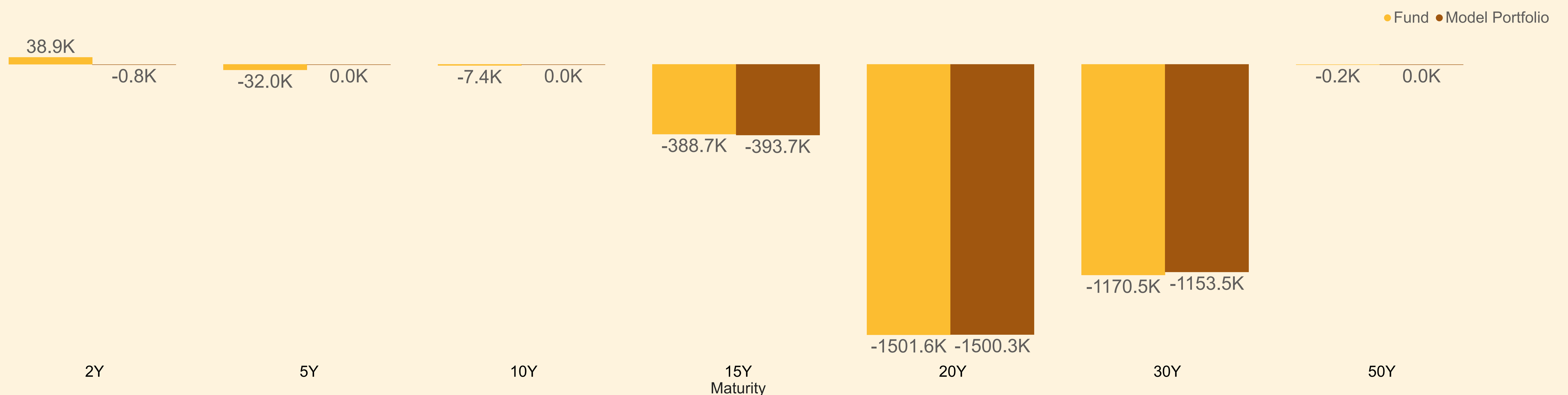


Sector Allocation (Top by Weight)
