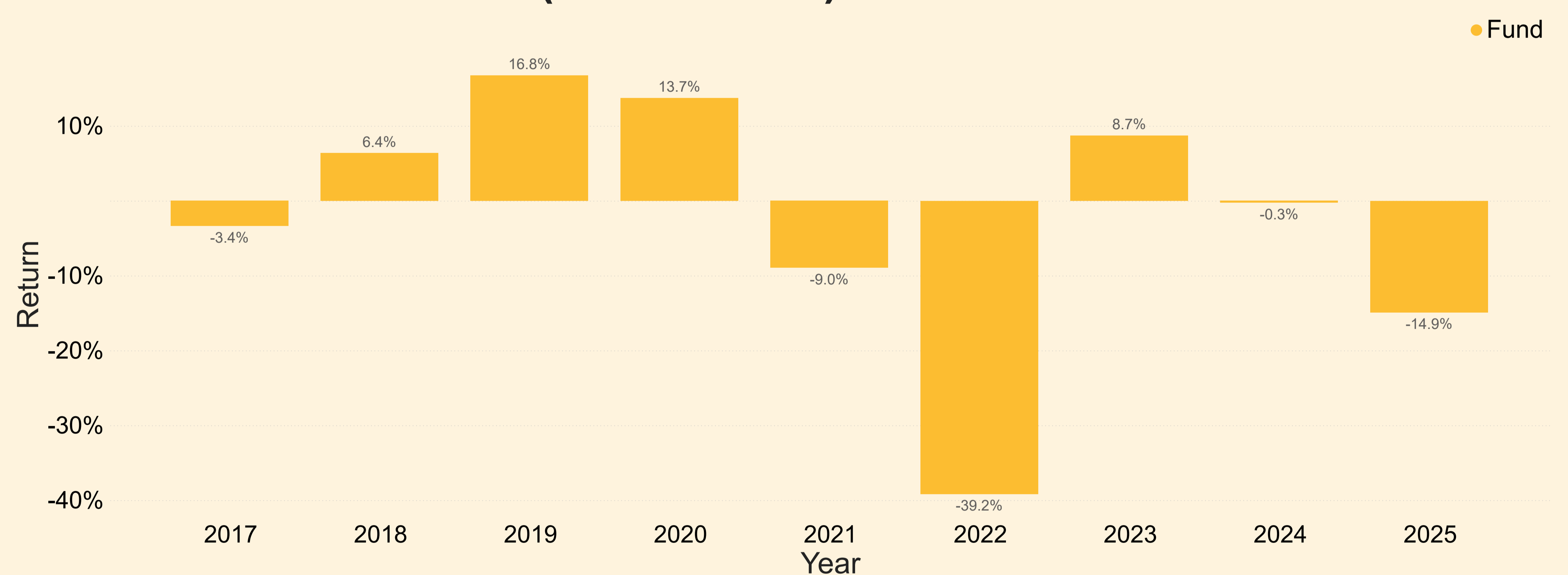

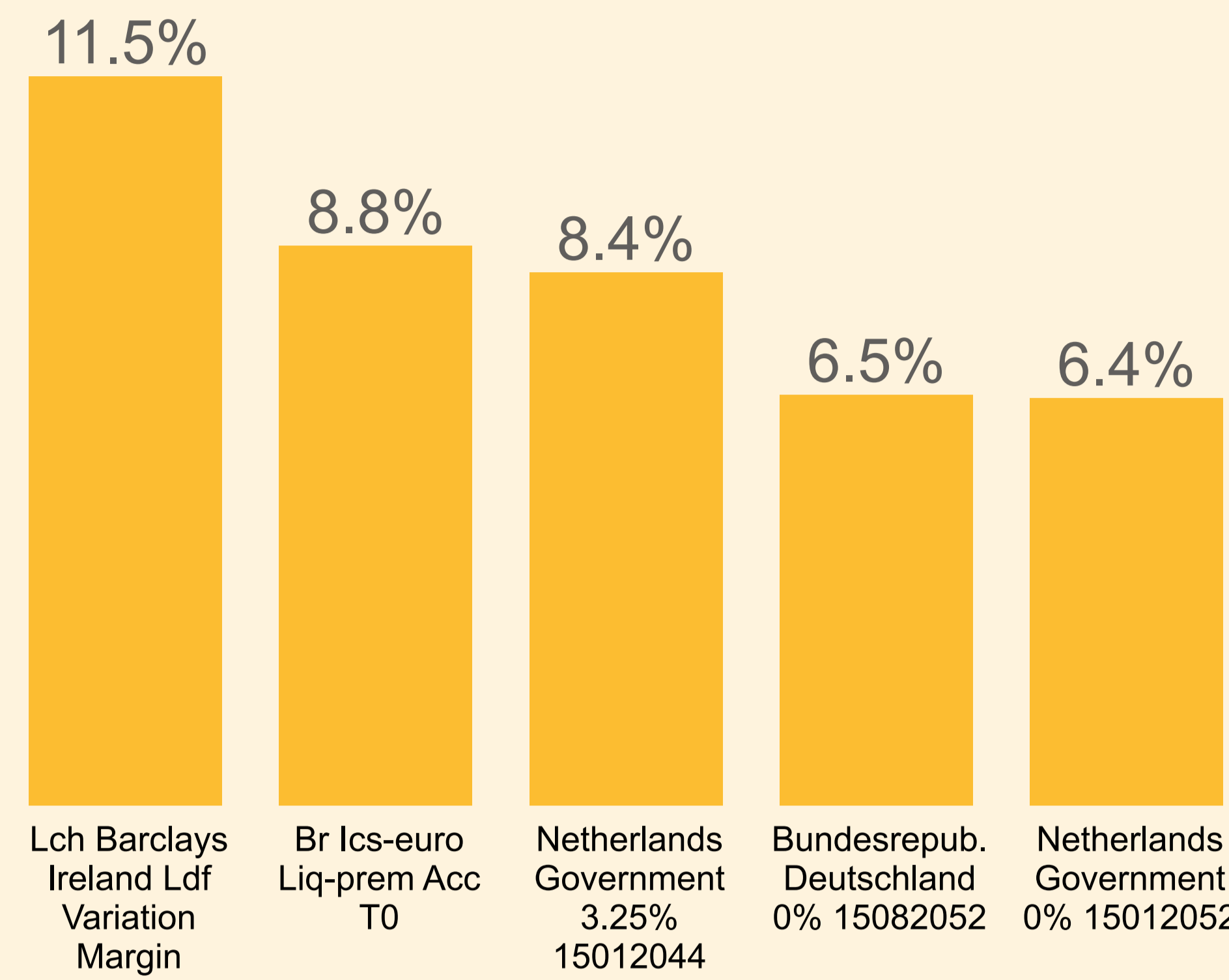

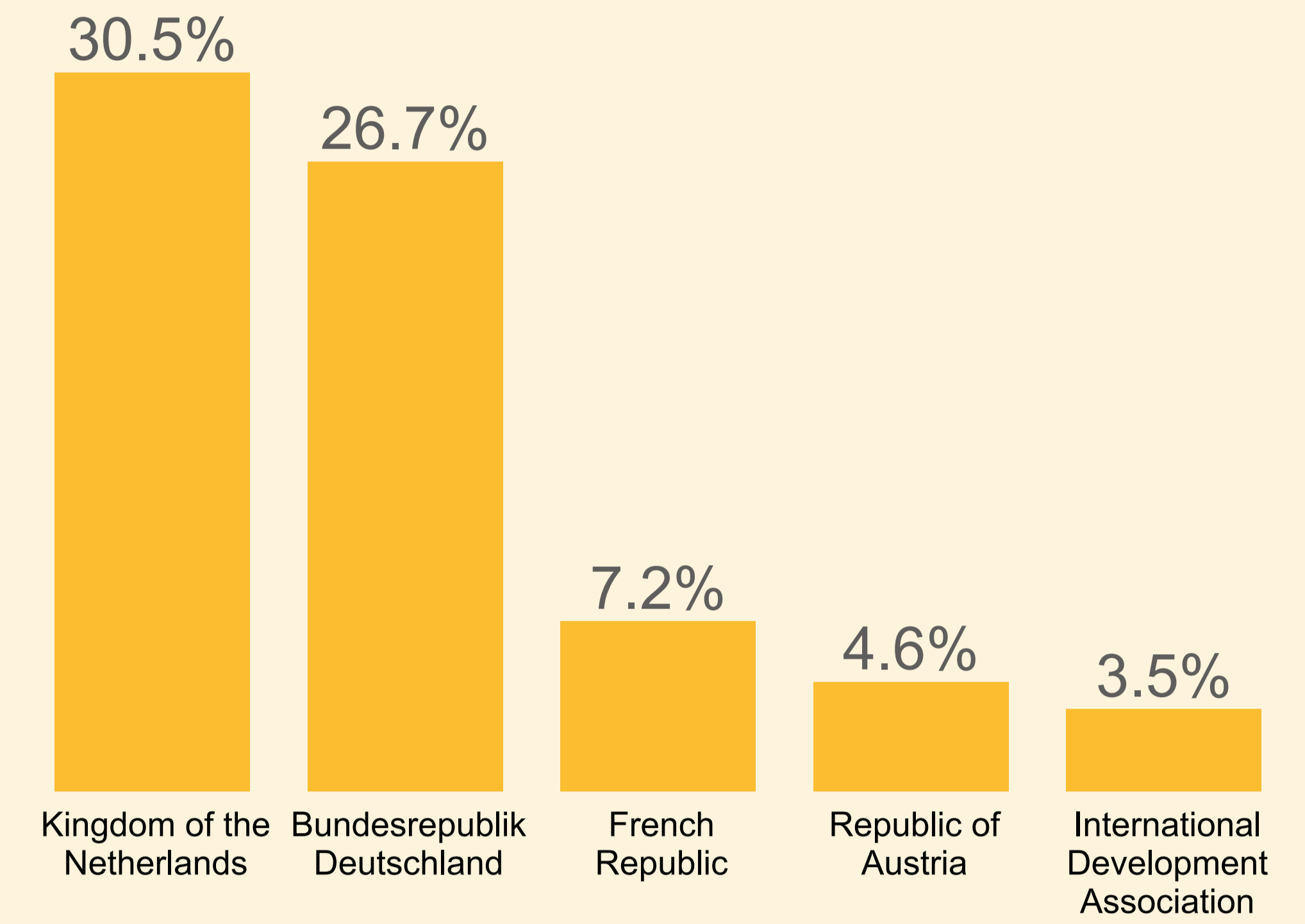

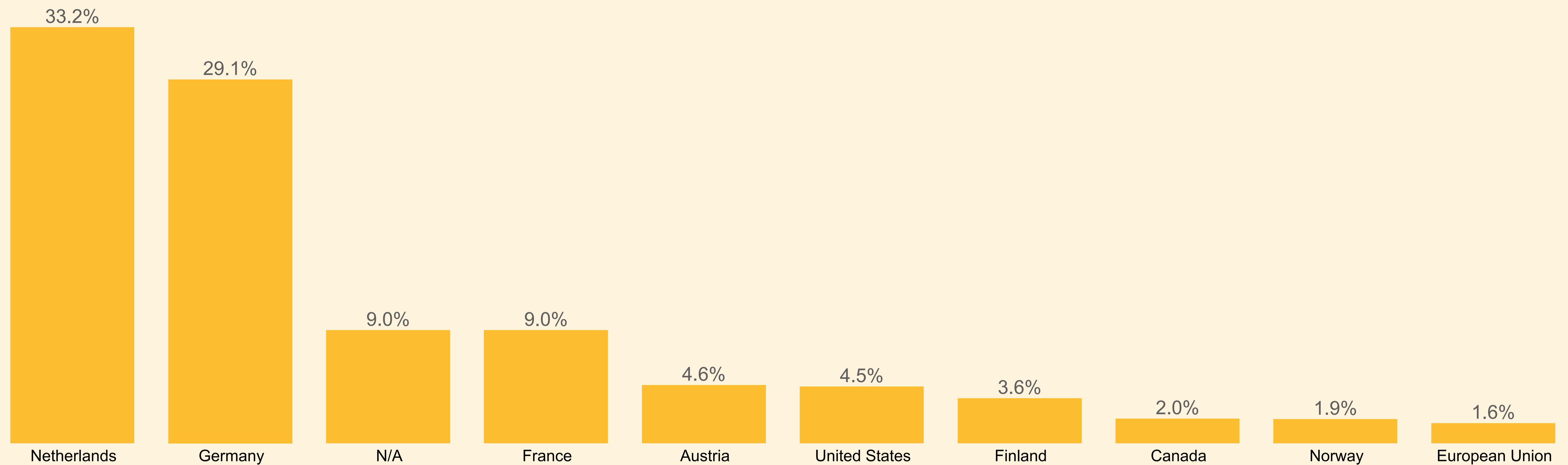
Top Holdings by Weight



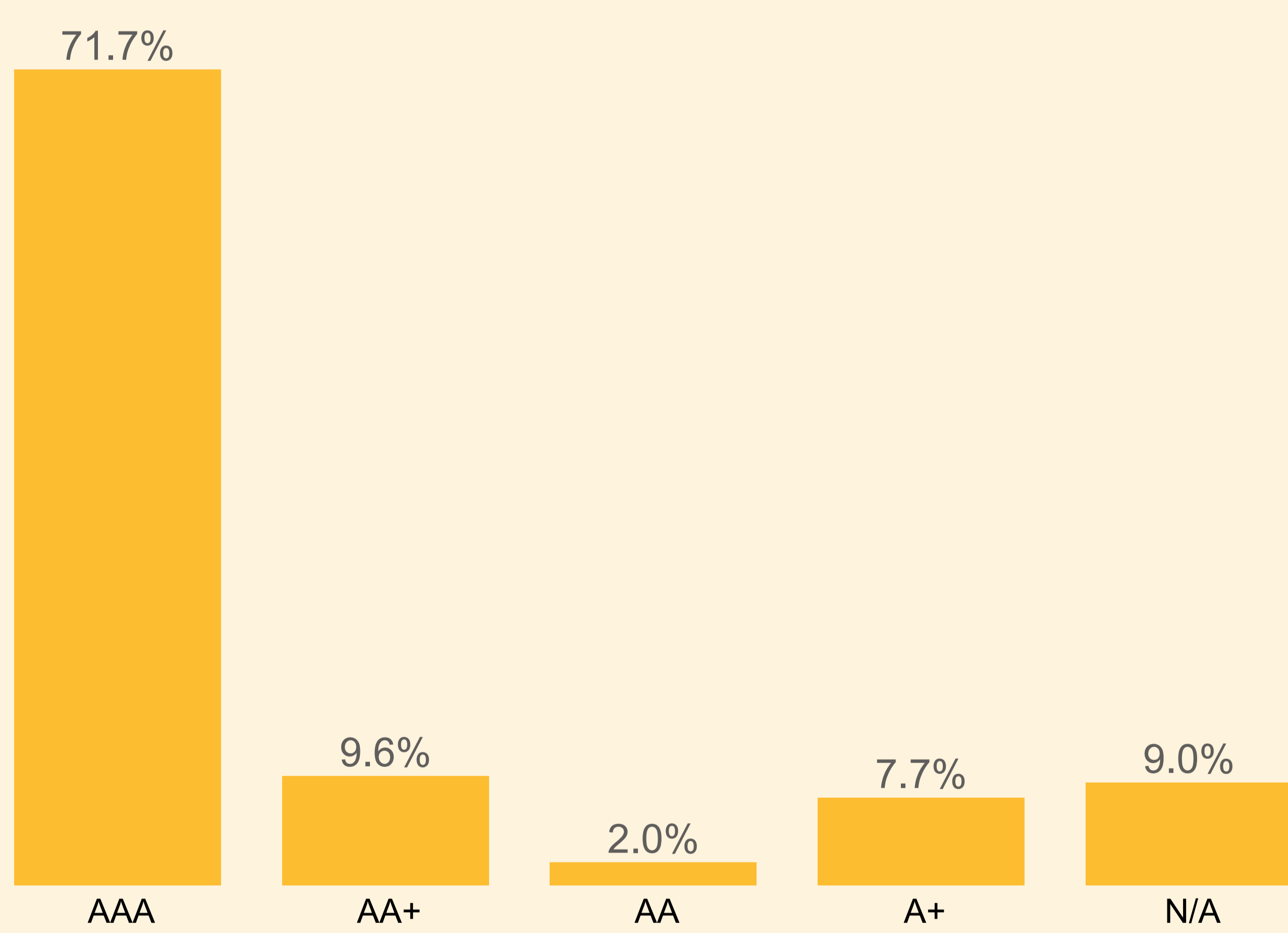

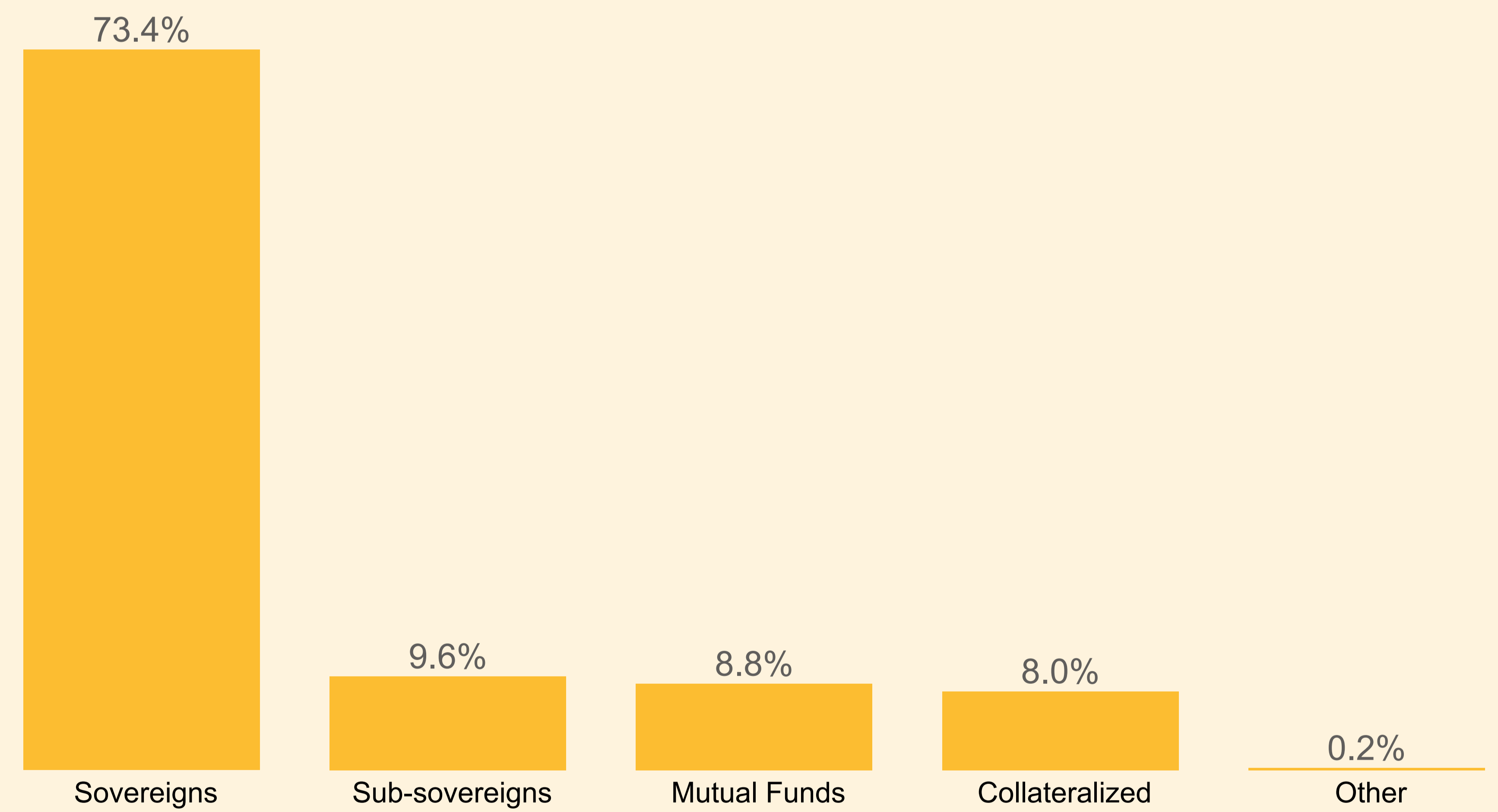
Country Allocation (Top by Weight)



Ratings Breakdown

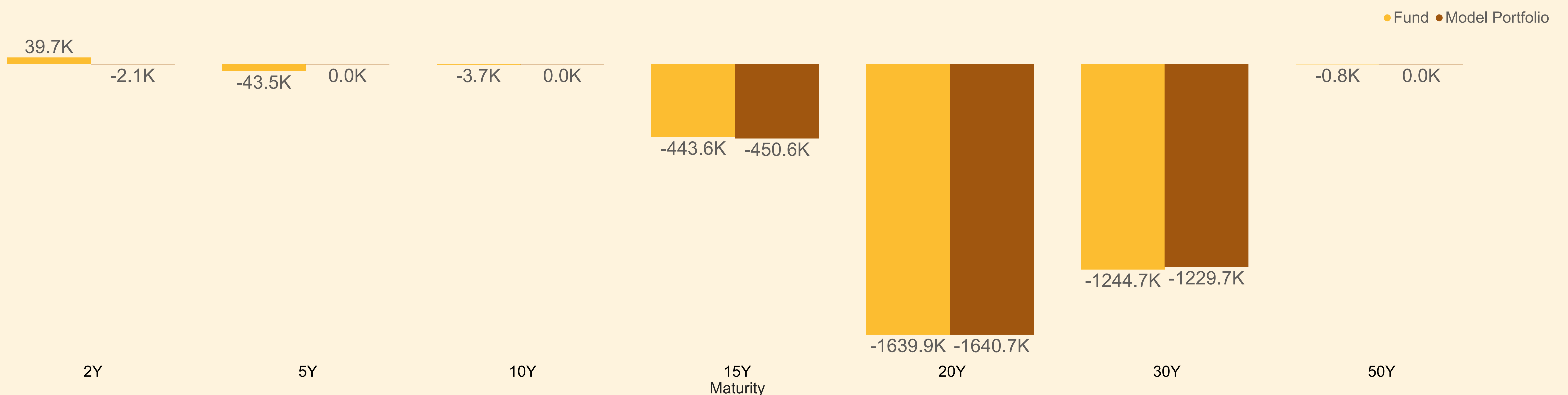


Sector Allocation (Top by Weight)
