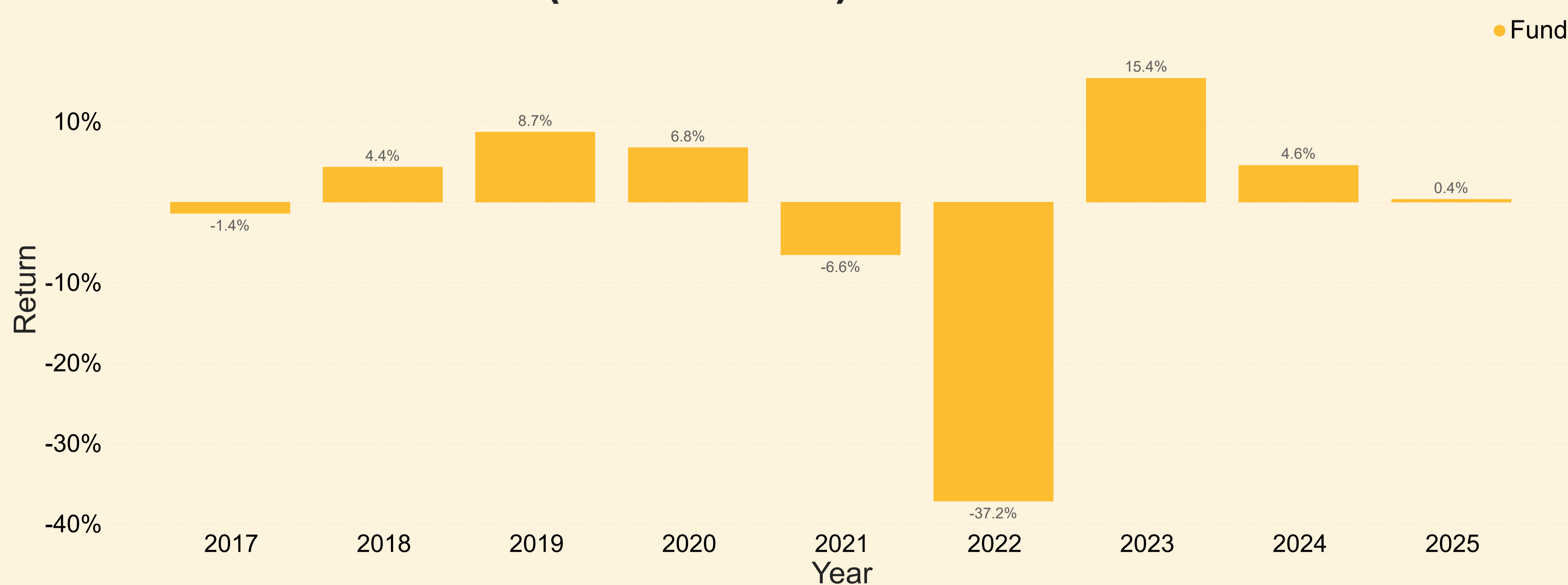

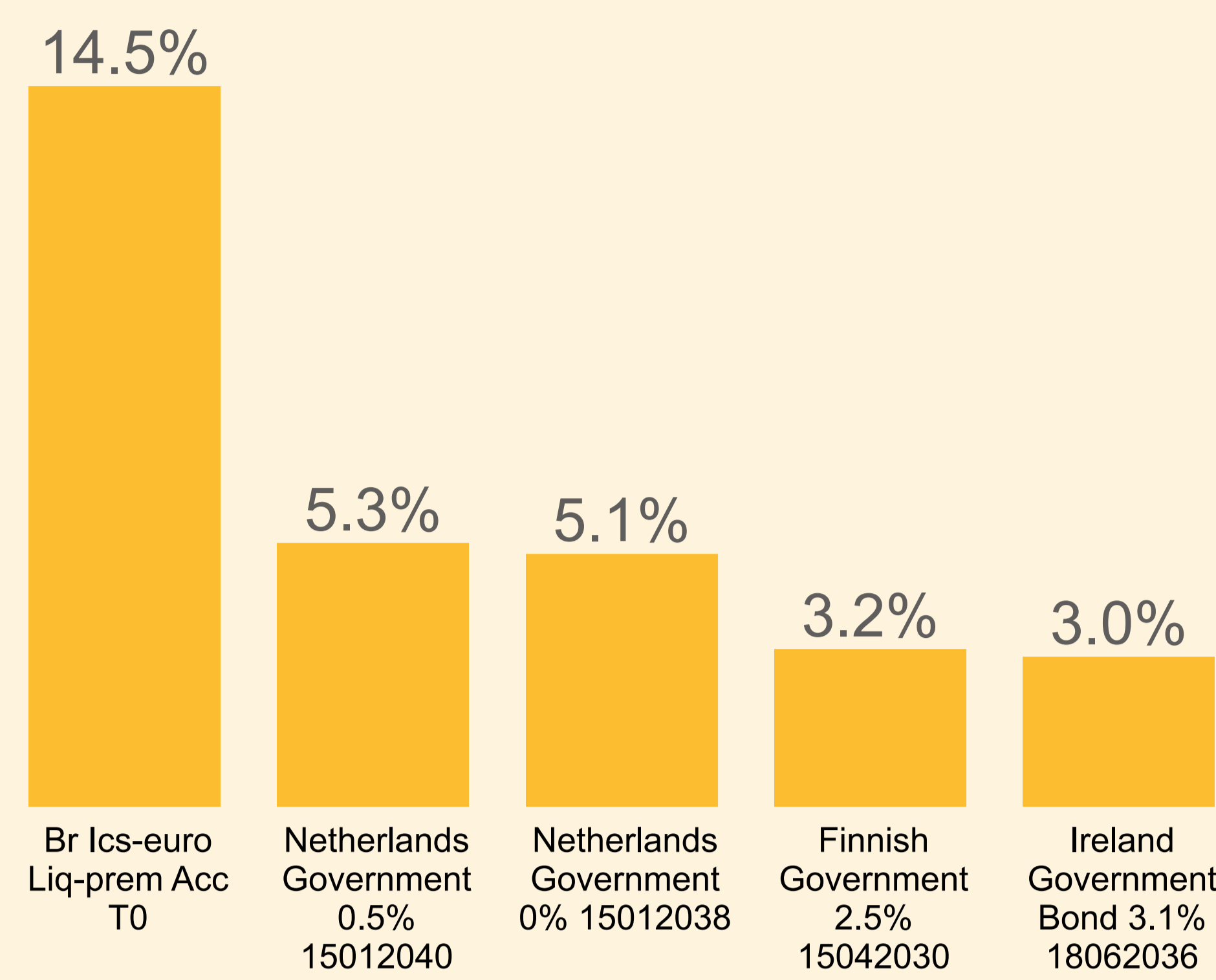

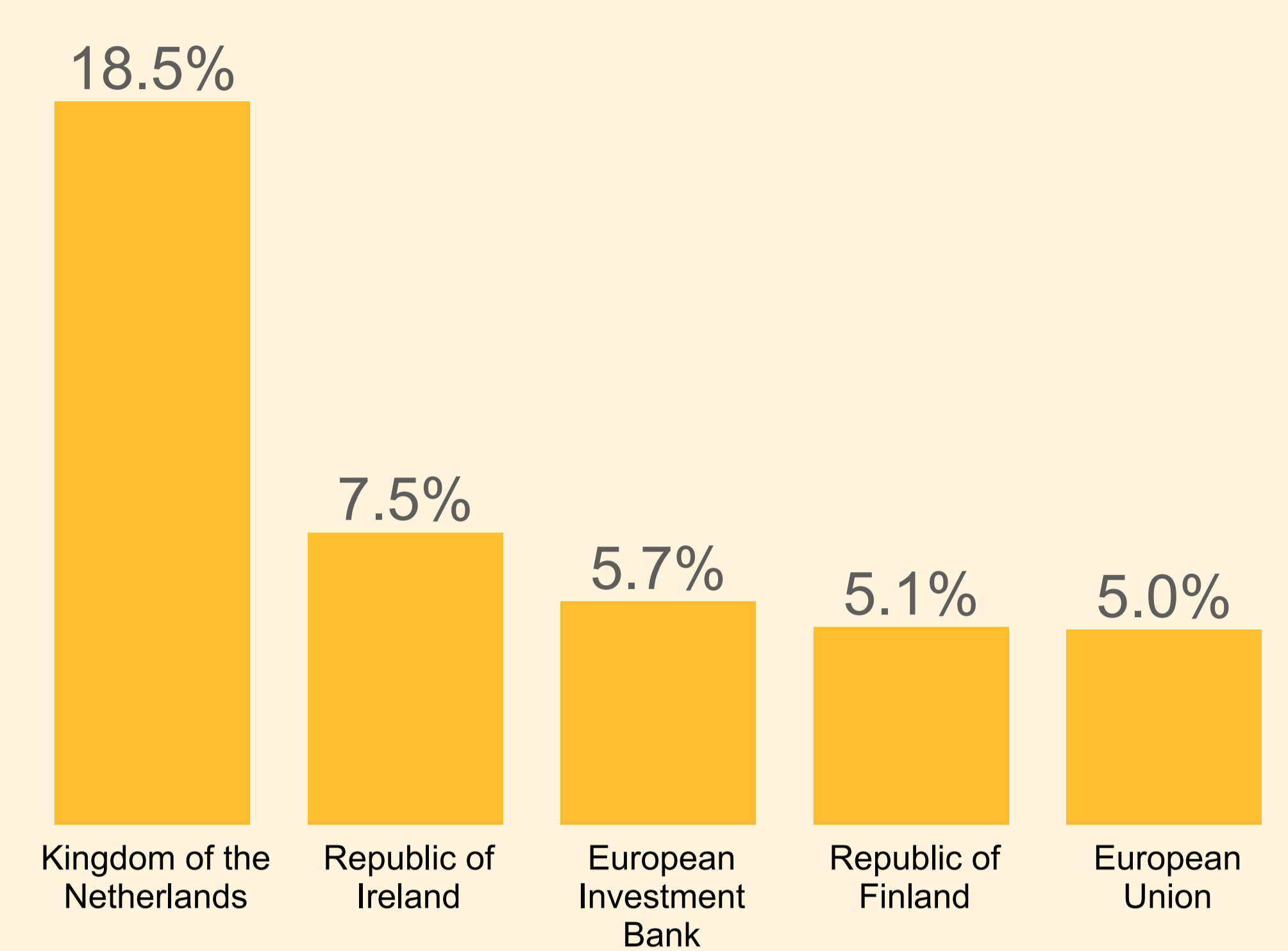

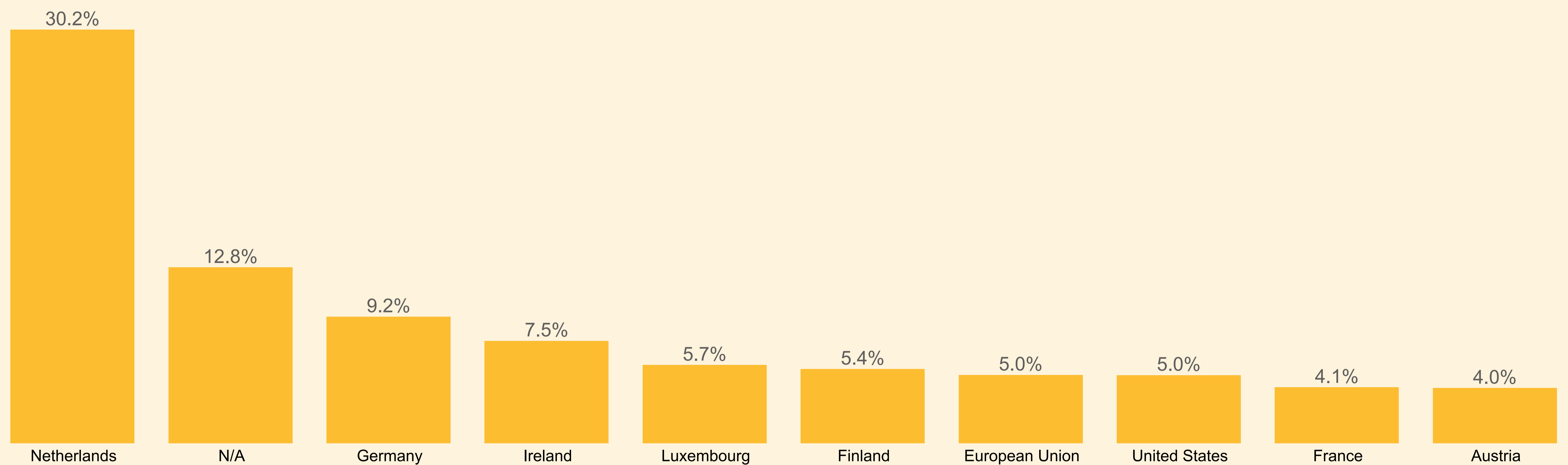
### Top Holdings by Weight



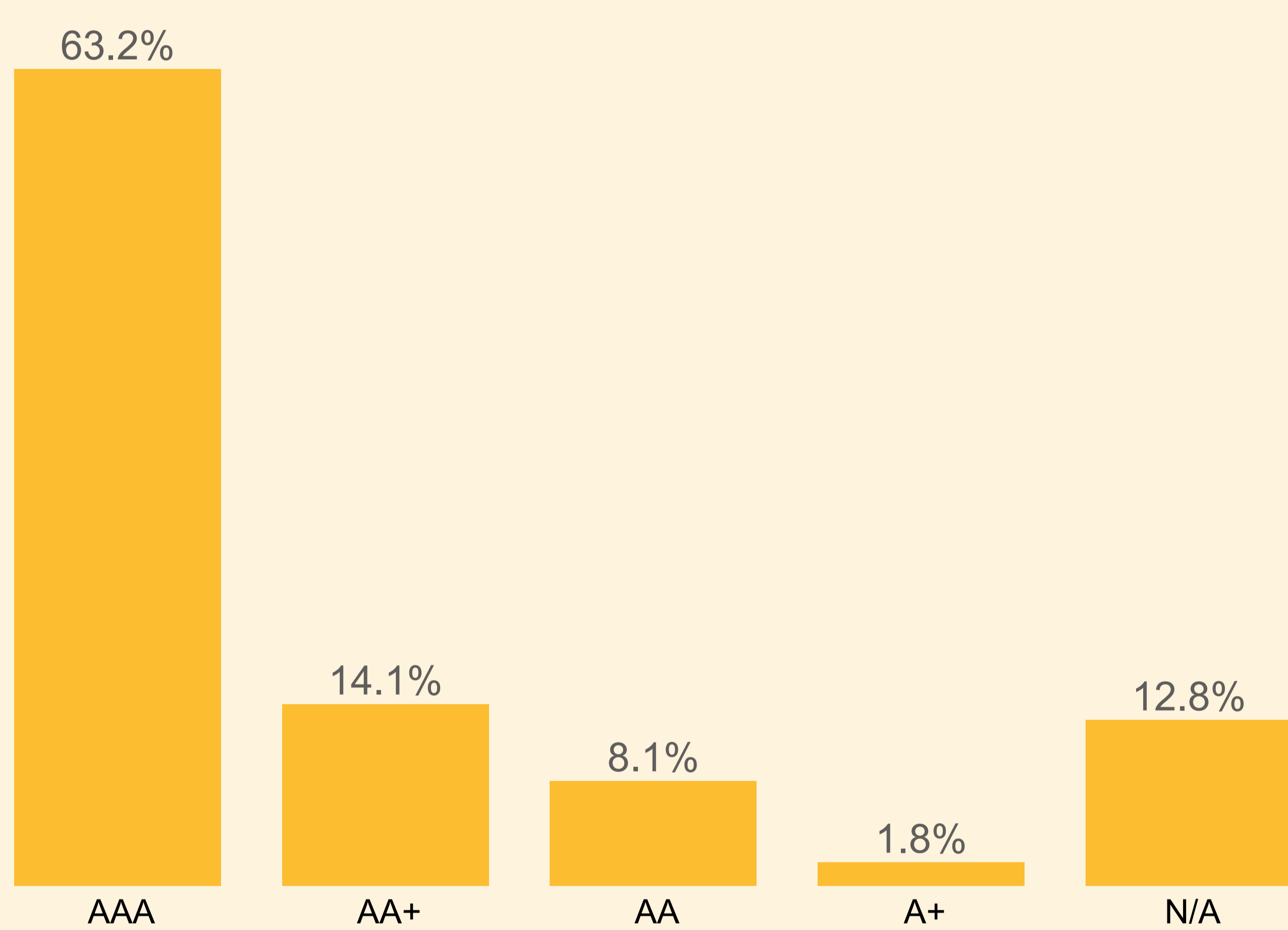

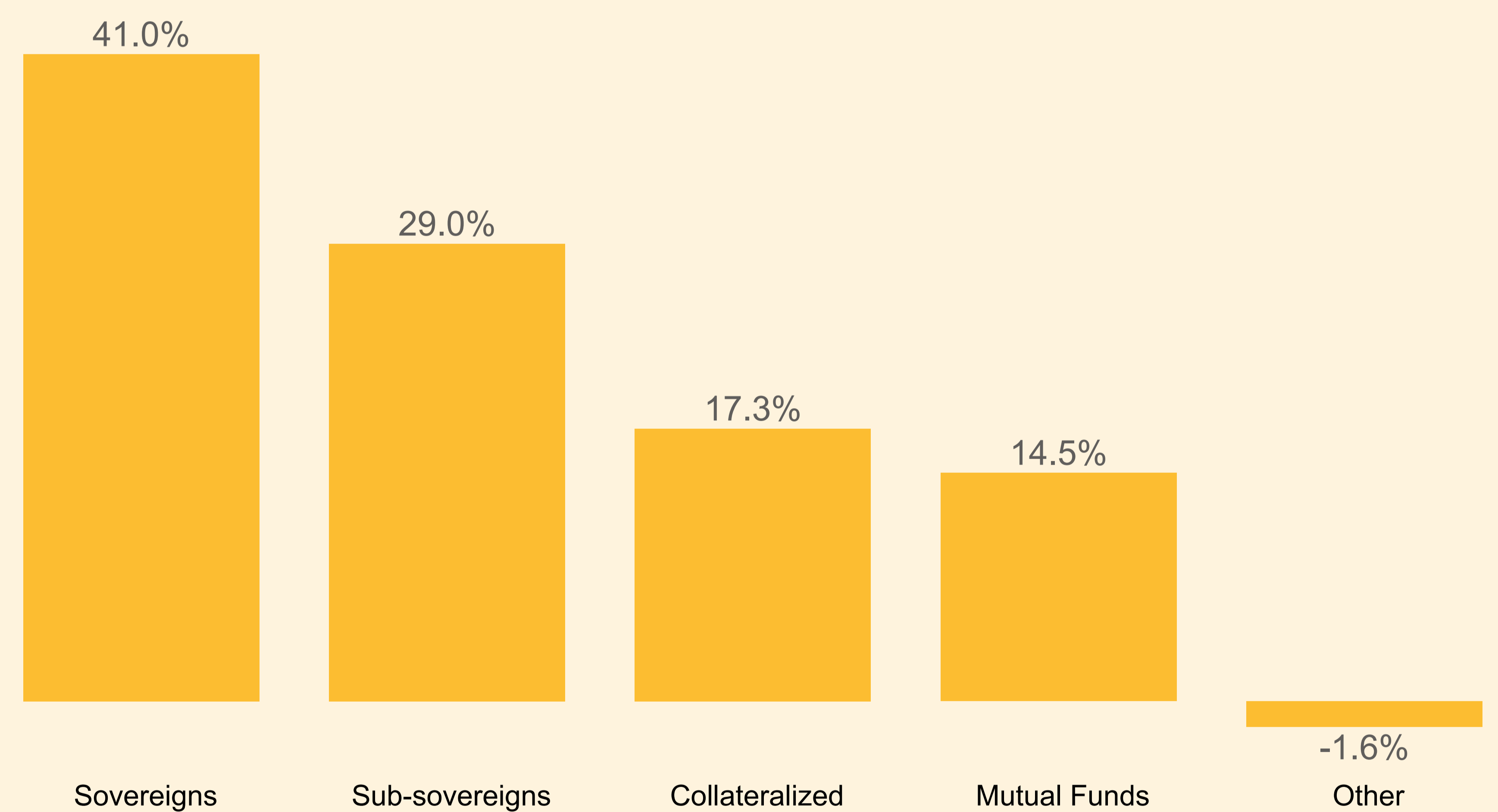
### Country Allocation (Top by Weight)

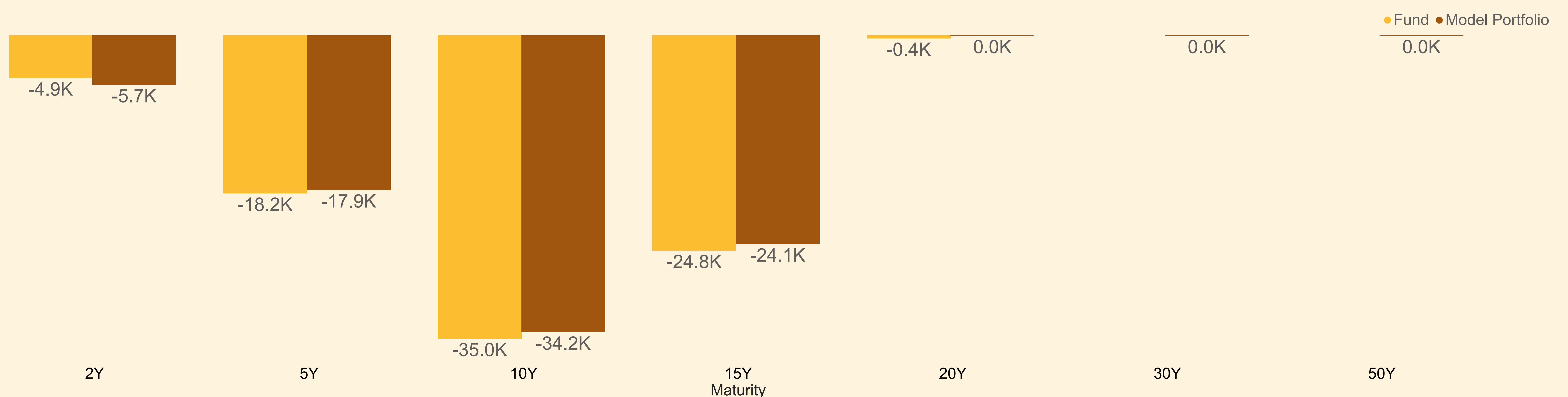


### Sector Allocation (Top by Weight)



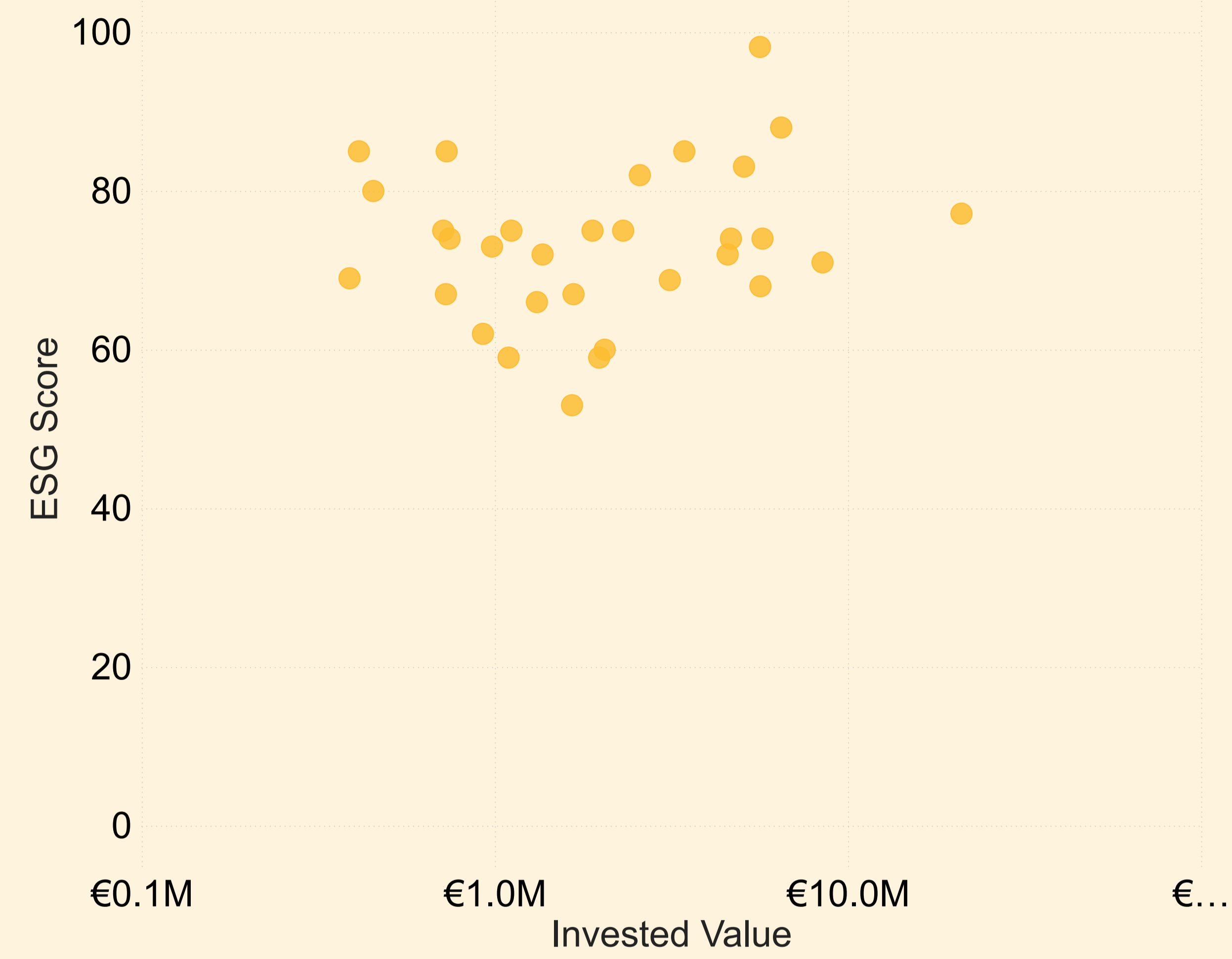
### Interest Rate Sensitivity per Maturity Bucket

As model portfolio we use cash flows that are included in the prospectus.



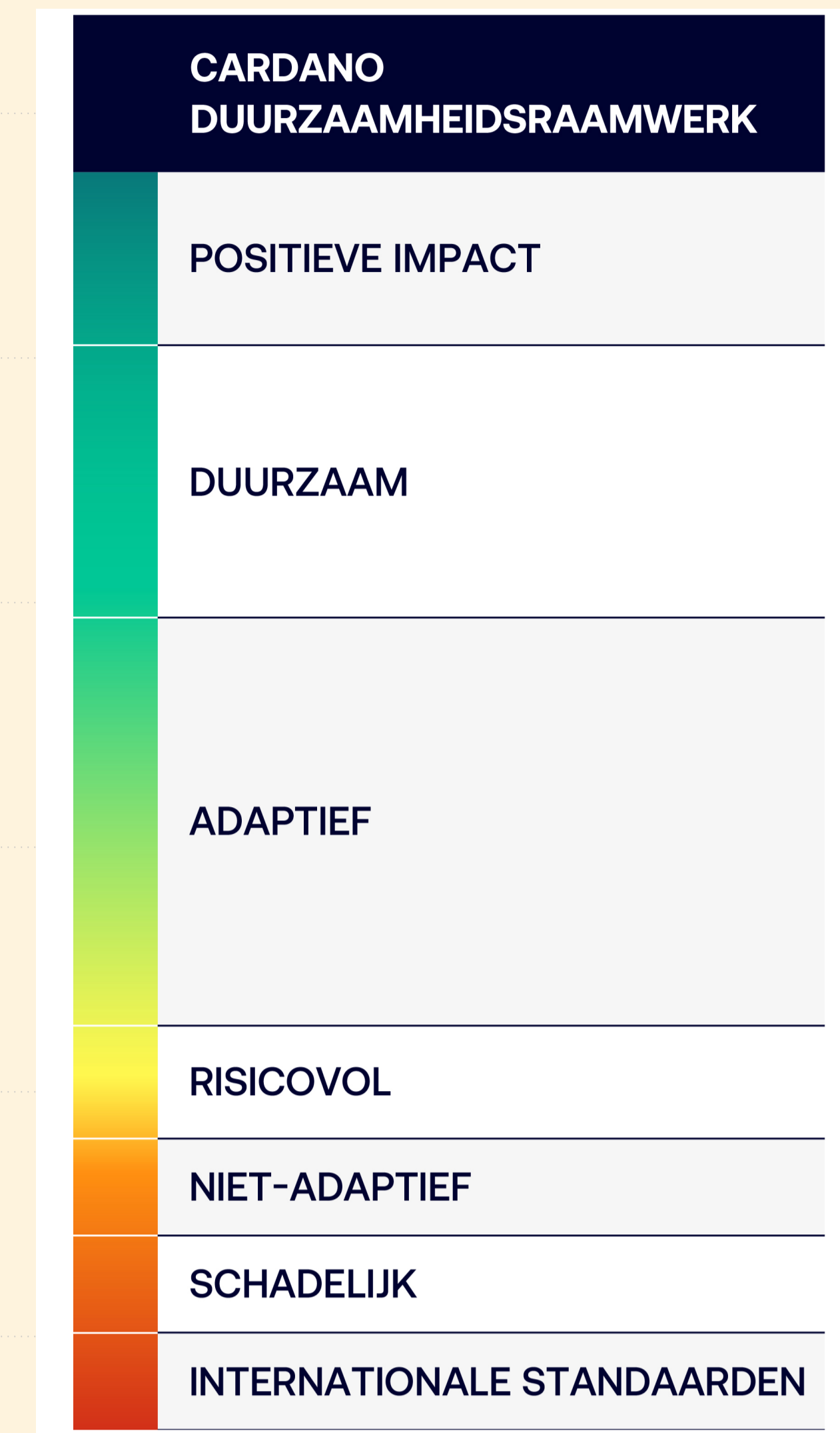
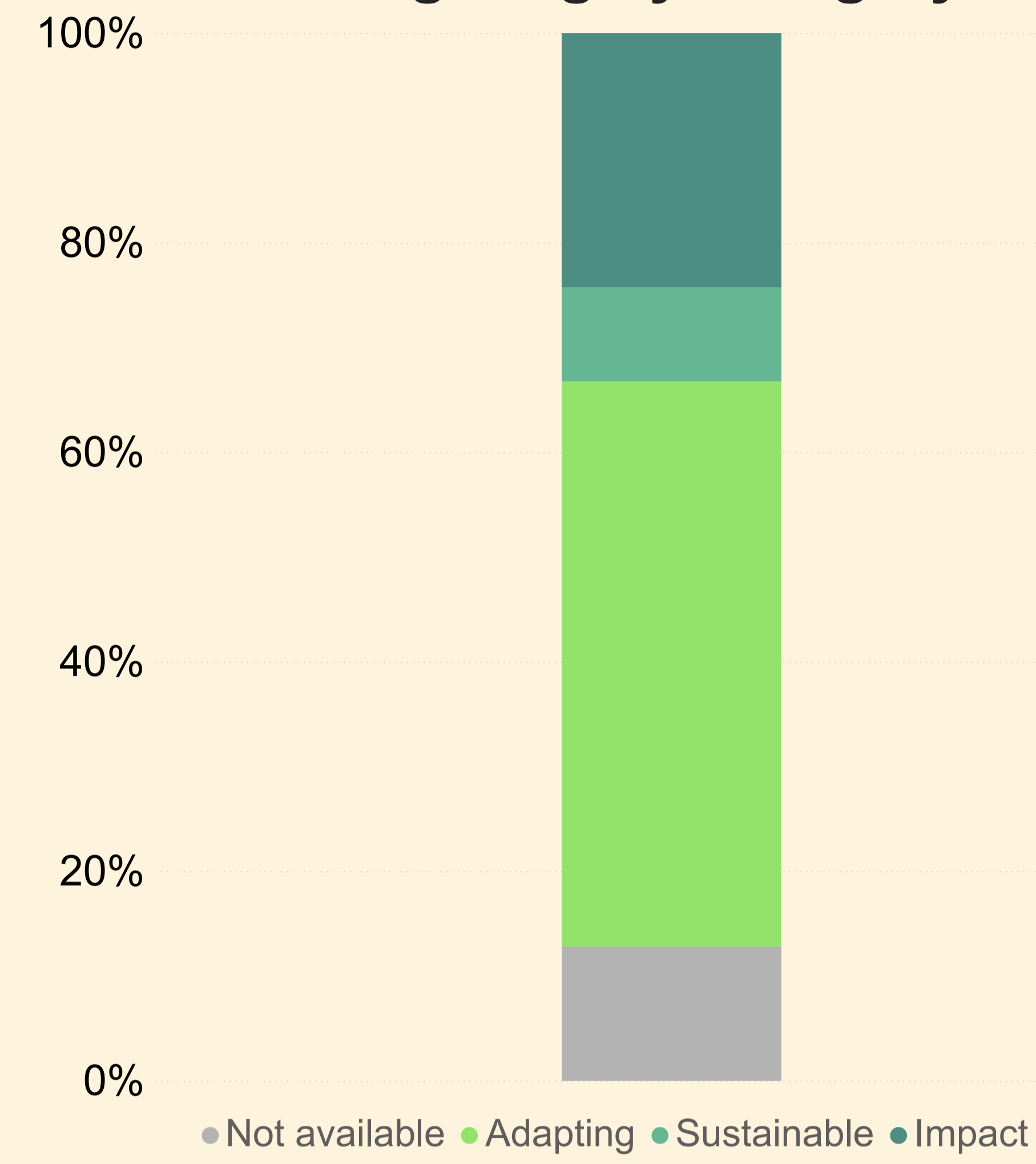
