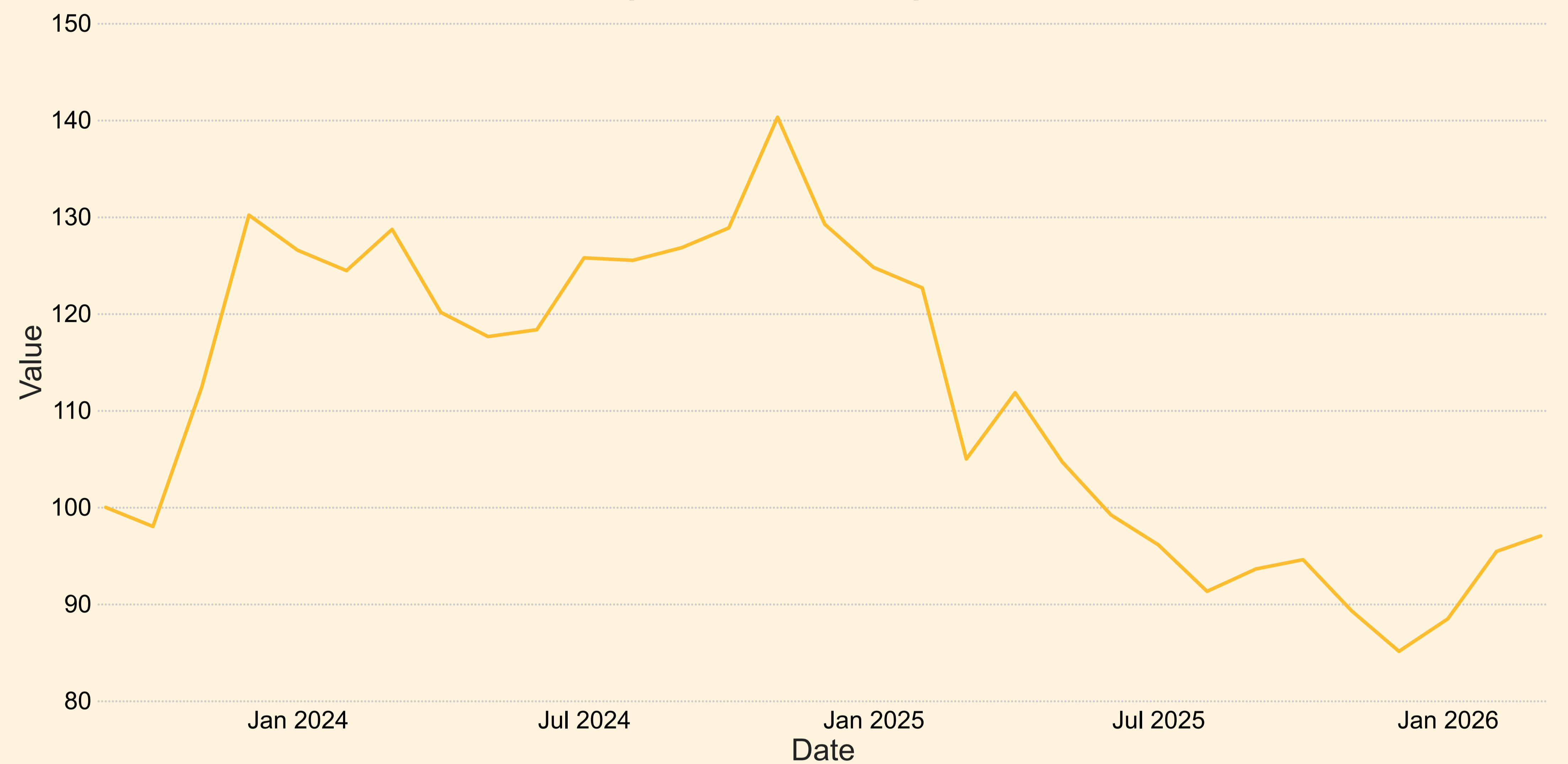

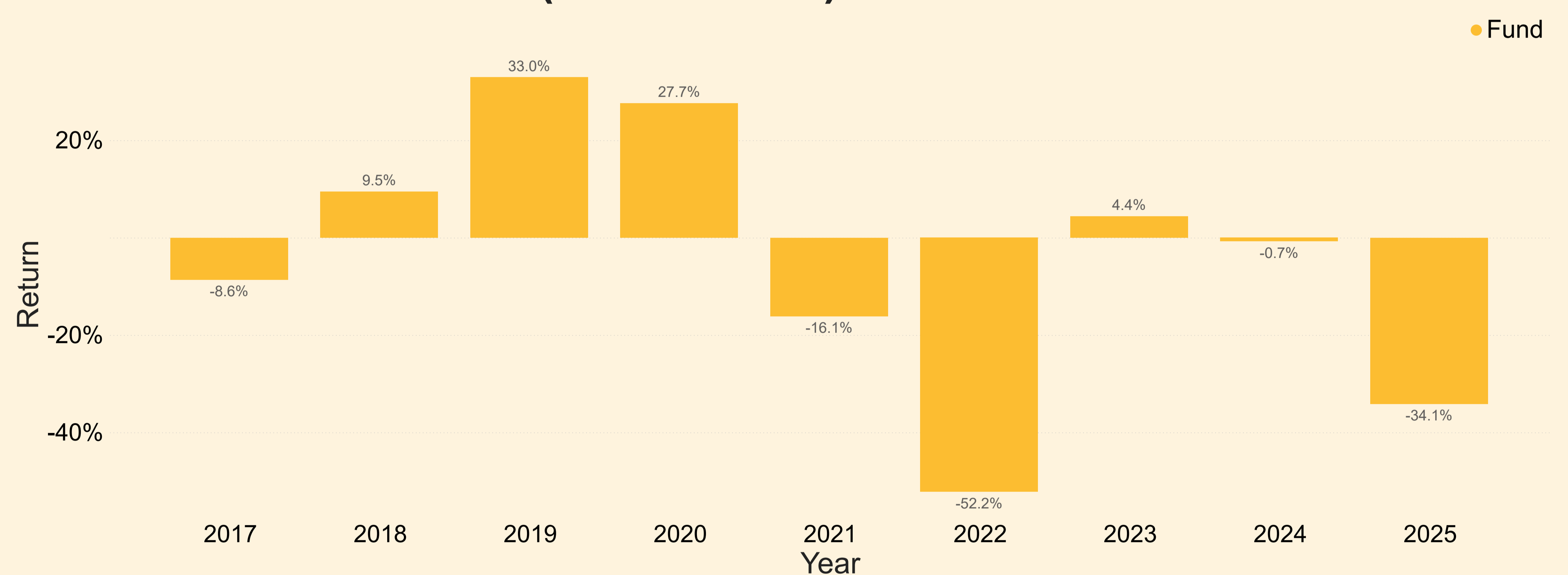

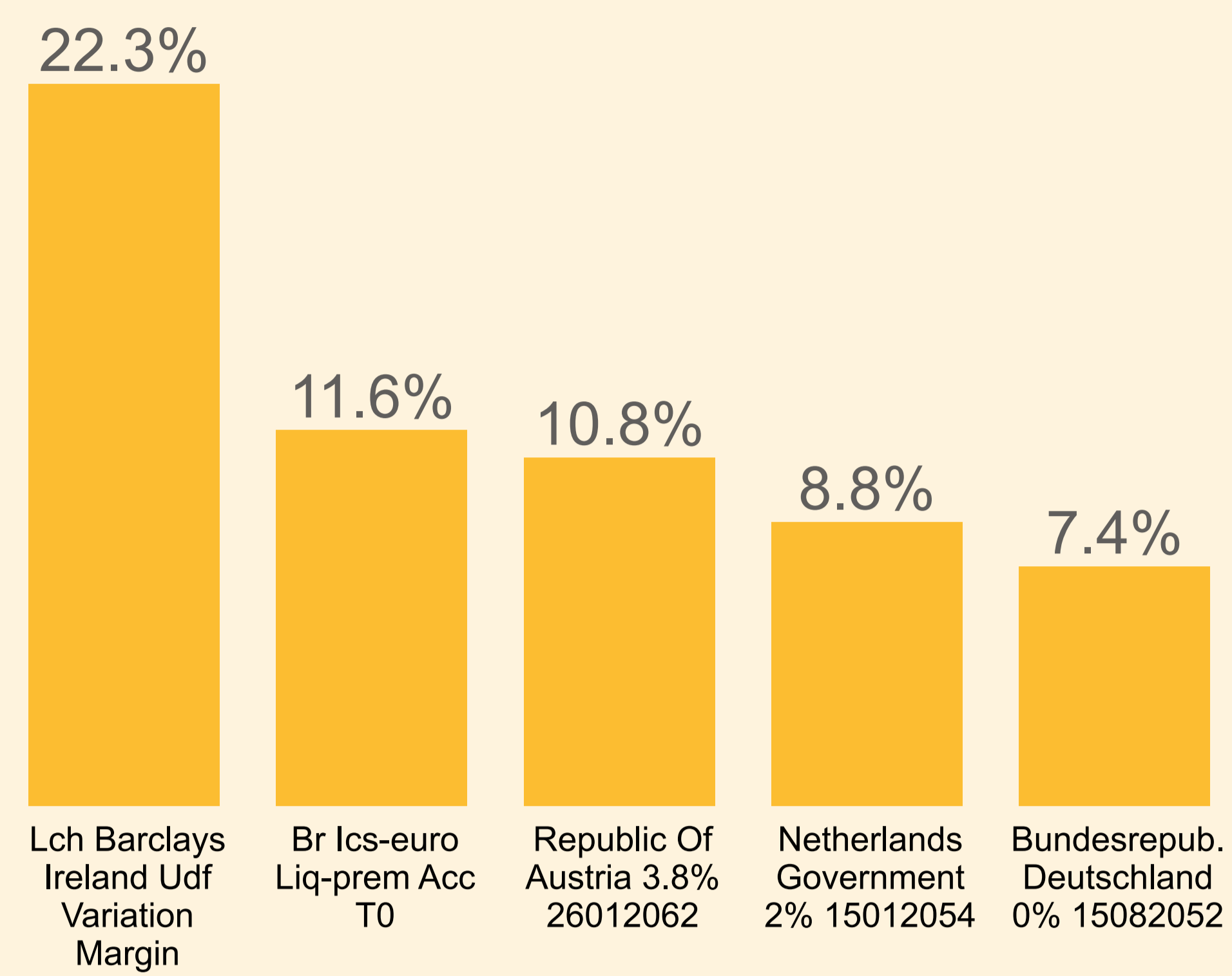

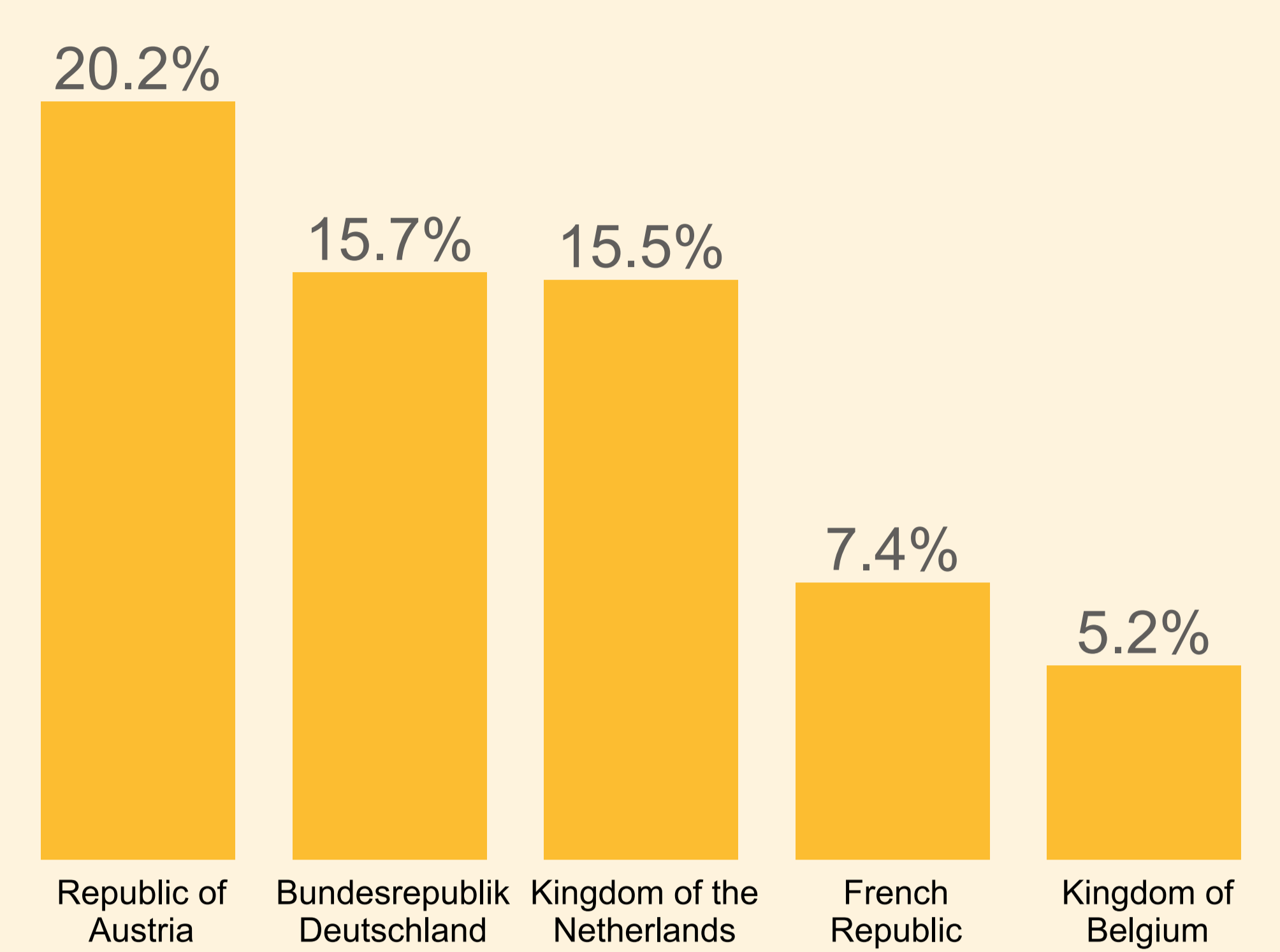

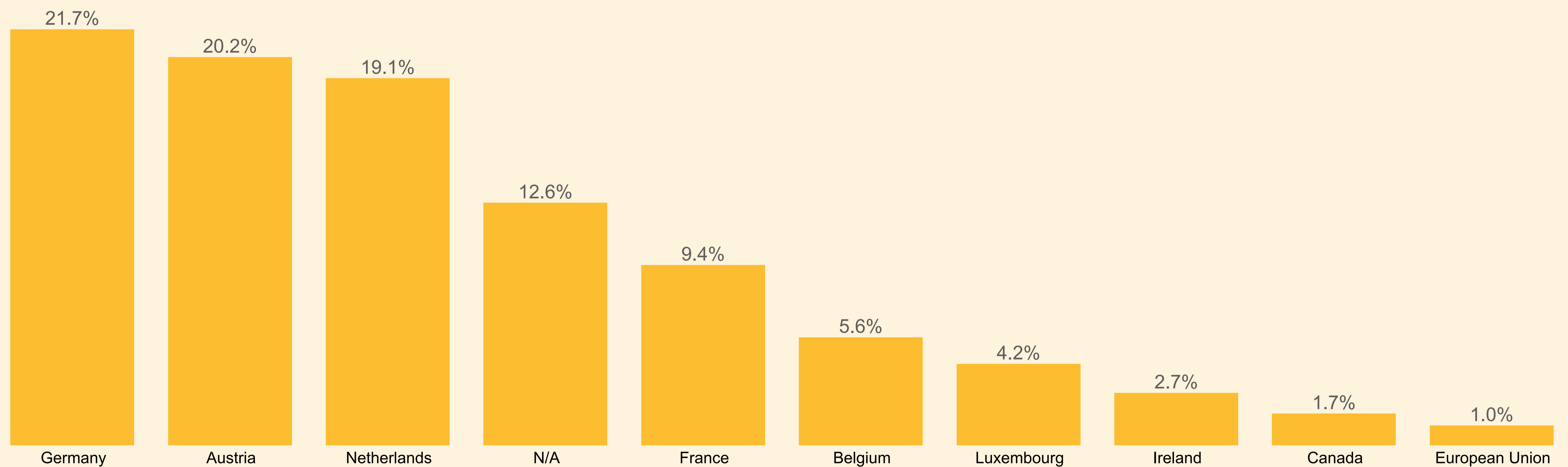
### Top Holdings by Weight



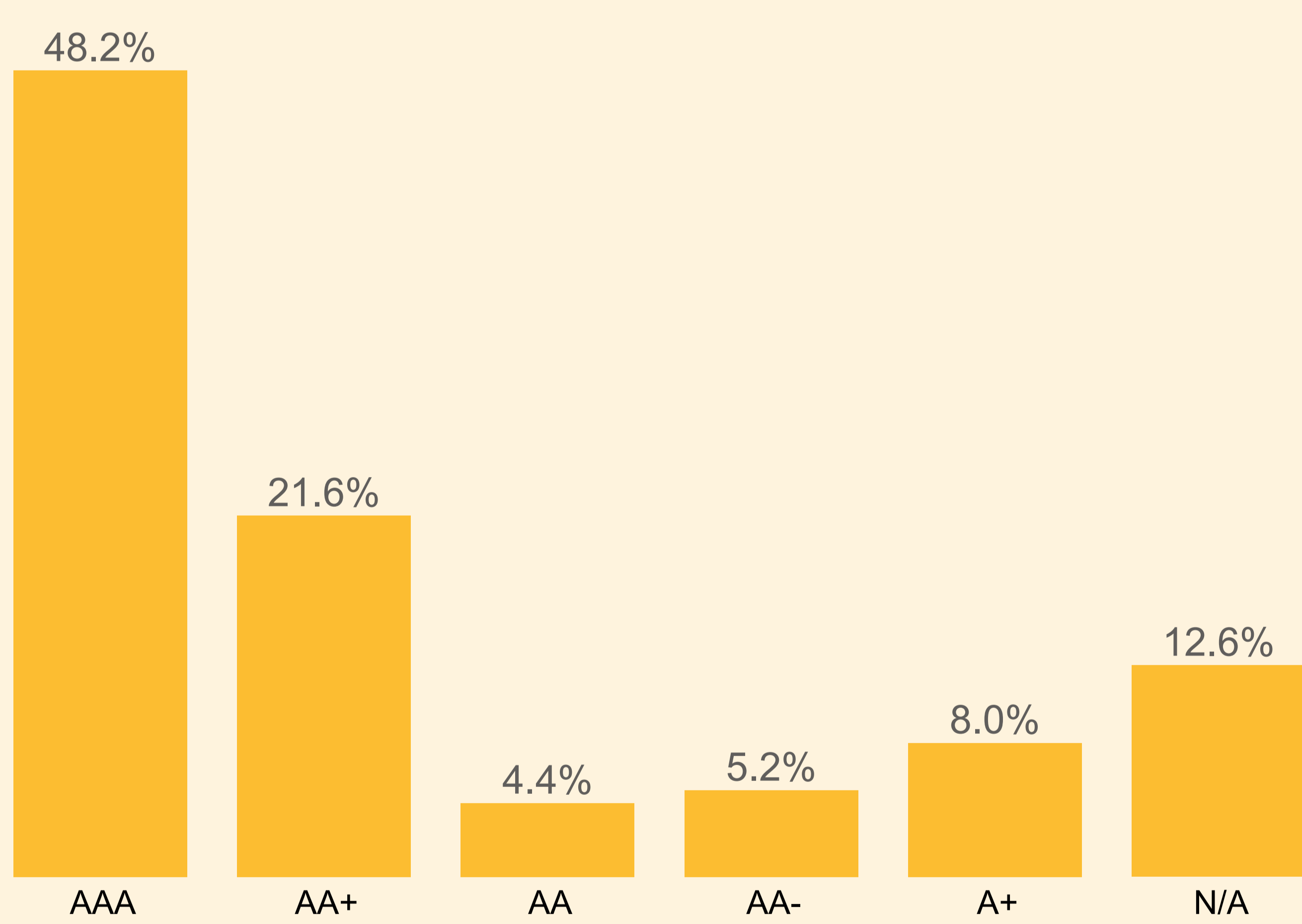

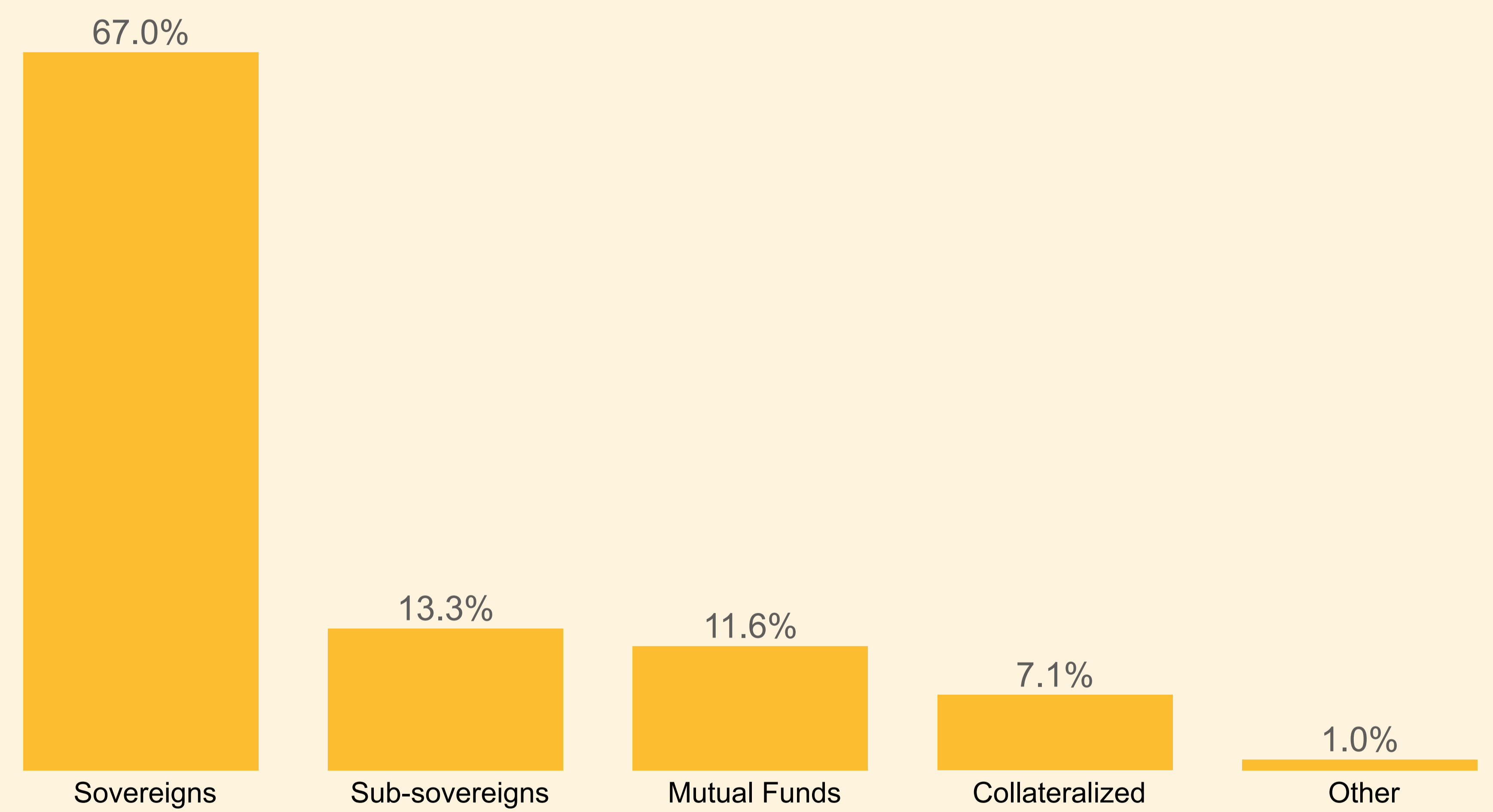
### Country Allocation (Top by Weight)

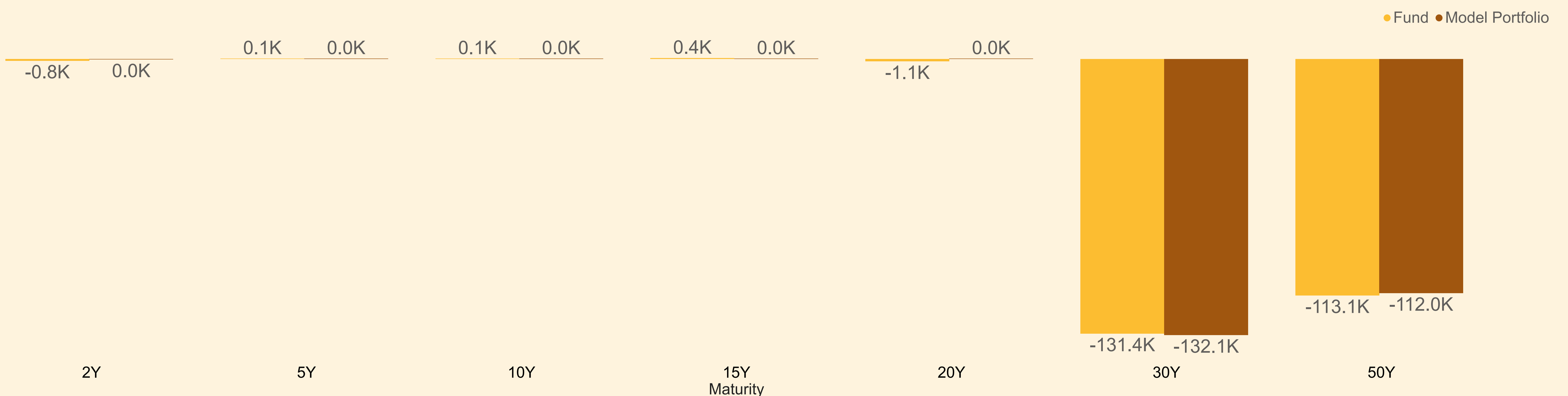


### Sector Allocation (Top by Weight)
