You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: This product is an investment fund that can in principle be traded daily and has an unlimited maturity.

Objective: The objective of Cardano ESG Transition Enhanced Index Equity Global is to approach the return of the MSCI World Index Net EUR, the benchmark ('Index'), as much as possible, while taking into account the applicable sustainability criteria. The fund also promotes environmental and social characteristics, within the meaning of Article 8 of the SFDR, and aims to contribute to long-term sustainability objectives in the field of the environment and social development and good entrepreneurship.

- The fund invests in (certificates of) shares of listed companies in Europe, North America and Asia-Pacific and may also temporarily invest in Exchange Traded Funds and derivatives, exclusively in equity futures.

- The fund is managed on the basis of a systematic investment policy by investing in (certificates of) shares of companies included in the Index, and in addition to that comply with Environment, Social and Governance (ESG) criteria. No investments are made in shares of companies that are excluded from investment based on the general exclusion criteria.

- The exclusion of companies leads to a deviation between the composite returns of the fund and the return of the Index. This deviation is minimised by investing the

proceeds in shares of companies with similar risk characteristics as of the excluded shares and at the same time meet the applicable ESG criteria.

- In any case, the fund aims to maintain an ESG score that is higher than the Index and a water and CO2-footprint that is lower than that of the Index.

- The fund takes into account the UCITS investment restrictions and does not invest more than 10% in institutions for collective investment.

- The currency risks arising from the portfolio investments are not hedged into euros.

- The fund pays out a cash dividend at least once a year.

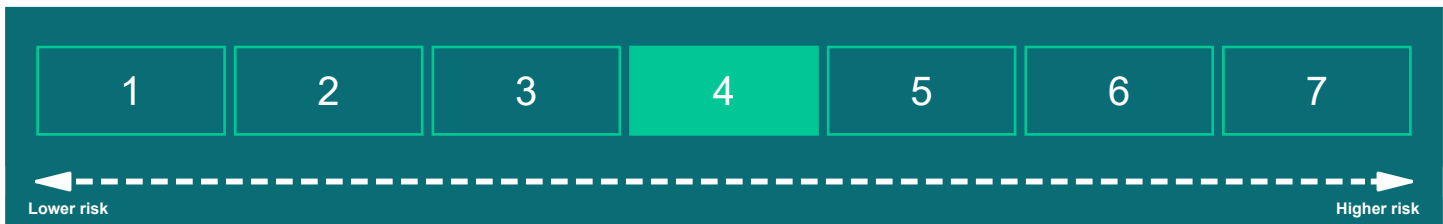
Cardano ESG Transition Enhanced Index Equity Global is suitable for private and professional investors who invest for the long term. The investor takes into account that he may lose all or part of the investment. Investing in the fund is suitable for both the basic investor with at least some knowledge of the relevant financial markets and products and the advanced investor. The basic investor is in any case able to make an informed investment decision on the basis of the basic information provided to him or by the legally prescribed documentation.

The fund has no end date. Cardano Asset Management N.V. may not unilaterally terminate the fund

What are the risks and what could I get in return?

Risk indicator





The risk indicator assumes you keep the product for the period as stated in the table below. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets. We have classified this product as 4 out of 7, which is a medium risk class. That means the potential losses on future performance are estimated as medium. What happens if Cardano Asset Management N.V. is unable to pay out?

Should Cardano Asset Management N.V. go bankrupt, this will have no direct consequences on the possibility of payment by the fund. If the fund is terminated or liquidated, the assets will be sold and you will receive an appropriate share of the proceeds, but you could lose some or all of your investment. Your loss will not be covered by any investor compensation or guarantee scheme.

How long should I hold it and can I take money out early?

Recommended holding periode: 5 years

Given the nature of the fund's underlying investments, a minimum holding period of 5 years is recommended. The fund generally invests in risk-bearing assets. Investments in the fund are less suitable for investors with a short-term investment horizon. Exit fees may be charged at the product level.
